HB 28	EDWARDS (TBA)	VETERANS Provides relative to the distribution of Honor Medals to veterans (Subject to Rule Suspension)
HB 33	ST. GERMAIN	INSURANCE/GROUP-SHERIFFS Provides relative to the payment of group insurance premiums for retired sheriffs and deputy sheriffs
HB 38	RITCHIE	COURTS/CITY Provides for an additional court cost in the City Court of Bogalusa
HB 52	HENDERSON	COURTS/TRAFFIC Provides for an increase in court costs in the Traffic Court of New Orleans
HB 60	GUILLORY	COURTS/COURT COSTS Authorizes an increase in court costs for municipal ordinance violations in the mayor's court in the town of Basile
HB 71	SMITH, JANE	CRIMINAL/VICTIMS Provides relative to victim notification
HB 72	GISCLAIR	LAW ENFORCEMENT Provides for the training of all chiefs of police
HB 176	ARMES	COURTS/CITY Provides for an increase in fees for the marshal of the City Court of Leesville
HB 205	CROMER	COURTS/CITY Authorizes the City Court of Slidell to have jurisdiction over certain cases to nullify judgments of bond forfeiture
HB 224	NOWLIN	COURTS/COURT COSTS Increases court costs in criminal cases in the 10 th JDC
HB 241	RICHARDSON	COURTS/JUSTICE OF PEACE Provides for the appointment of a clerk of the justice of the peace court in East Baton Rouge Parish

HB 270	DANAHAY	CLERKS OF COURT Provides for insurance coverage upon retirement for a clerk or clerk employee that retires under the clerks of court retirement program
HB 274	LAMBERT	PRIVATE SECURITY Provides relative to hospital security and police jurisdiction
HB 317	GISCLAIR	MTR VEHICLE/EMERGENCY Provides for revisions for bicycles used by peace officers
HB 402	HUVAL	COURTS Increases the civil jurisdictional amount in dispute for the City Court of Breaux Bridge
HB 407	WHITE	COURTS/DISTRICT Establishes a judicial building fund for the construction of a new courthouse in the Twenty-First Judicial District Court in Livingston Parish
HB 553	FOIL	COURTS/COURT COSTS Provides for a uniform fines and costs assessment form for criminal cases
HB 556	FOIL	COURTS/COURT COSTS Provides for court costs to implement an integrated juvenile justice information system
