HCR 131	HARRISON (TBA)	TRANSPORTATION Provides relative to human services transportation (Subject to Rule Suspension)
HB 130	MONTOUCET	TRANSPORTATION Requires DOTD to present highway priority program information in a certain format
HB 334	CHAMPAGNE	LEVEES/BDS & DISTRICTS Creates the Vermilion Parish Levee, Hurricane Protection, and Conservation District
HB 338	STIAES	MOTOR VEHICLES Prohibits drivers from using handheld cellular devices while driving
HB 475	LORUSSO	LEVEES Provides relative to membership of the Non-Flood Protection Asset Management Authority and the sale of non-flood assets
HB 572	BARROW	TRANSPORTATION Requires certain child care facilities to install child safety alarms in any vehicle used to transport children
SB 58	ADLEY	MOTOR VEHICLES Removes the DPS&C handling fee from the United States Armed Forces military honor license plate. (8/15/11)
SB 66	RISER	EMPLOYMENT Requires verification of legal work status of employees by private employers seeking to contract with state agencies. (8/15/11)
SB 100	MURRAY	PUBLIC CONTRACTS Increases the number of working days prior to the opening of bids within which a potential supplier must submit a request for approval of a product other than that specified in the contract documents in public works projects of the New Orleans Sewerage and Water Board. (gov sig)
SB 132	ERDEY	ROADS/HIGHWAYS Provides for the application of the latest federal decennial census in determining population classes regarding certain transportation funding and maintenance of certain highways and DOTD facilities. (8/15/11)

SB 164	ERDEY (TBA)	DRIVER EDUCATION Requires currently licensed or contracted third-party testers administering driver's education courses to be licensed or contracted to administer on-road driving skills tests; requires such third-party testers to administer such test; and requires driver education courses or "prelicensing training courses" before issuance of most first-time driver's licenses (8/15/11) (Subject to Rule Suspension)
SB 166	WALSWORTH	PORTS/HARBORS/TERMINALS Provides for the membership of the Greater Ouachita Port Commission. (gov sig)
SB 222	MILLS	MOTOR VEHICLES Requires driver education courses, training programs, and prelicensing training courses for children and adults to include teaching the economic effects of littering. (1/1/12)
SB 252	ERDEY (TBA)	SPECIAL DISTRICTS Authorizes the Livingston Parish Gravity Drainage District to levy their own 1/2 cent sales tax. (8/15/11) (Subject to Rule Suspension)
