<b>HB 242</b>	<b>HARRIS</b>	<b>CIVIL SERVICE/FIRE &amp; POL</b> Provides relative to the position of deputy chief of police in the city of Alexandria
<b>HB 335</b>	<b>LORUSSO</b>	<b>DISTRICTS/SPECIAL</b> Relative to the New Orleans City Park Taxing District, provides with respect to procedures relative to use of state sales tax increments for tax increment financing
<b>HB 681</b>	<b>LEGER</b>	<b>ENERGY</b> Provides relative to energy efficiency or renewable energy improvement loans
<b>HB 1103</b>	<b>LEGER</b>	<b>DISTRICTS/SPECIAL</b> Provides relative to the La. Sports and Entertainment District
<b>HB 788</b>	<b>ST. GERMAIN</b>	<b>PROPERTY</b> Provides relative to the annexation of property by municipalities
<b>HB 905</b>	<b>EDWARDS</b>	<b>DISTRICTS/SPECIAL</b> Creates the St. Helena Parish Elderly Services District
<b>HB 934</b>	<b>LIGI</b>	<b>TAX/LEASE</b> Authorizes Jefferson Parish to create an automobile rental tax district
<b>HB 968</b>	<b>ARNOLD</b>	<b>TRAFFIC</b> Prohibits an unpaid traffic citation that was issued by an automated traffic enforcement system from being sent to a collection agency
<b>HB 1105</b>	<b>JACKSON, K</b>	<b>DISTRICTS/HOSPITAL SERVC</b> Authorizes certain parish governing authorities to pay a commissioner's fee to members of the governing board of any hospital service district located in the parish
<b>HB 889</b>	<b>CHAMPAGNE</b>	<b>DISTRICTS/TAXING</b> Exempts certain businesses from sales and use taxes levied by economic development districts that have tax increment financing authority
<b>HB 890</b>	<b>CHAMPAGNE</b>	<b>DISTRICTS/TAXING</b> Repeals provisions that authorize local governmental subdivisions to create certain economic development districts

<b>HB 891</b>	<b>CHAMPAGNE</b>	<b>DISTRICTS/TAXING</b> Requires voter approval prior to the creation of certain economic development districts by local governmental subdivisions
<b>HB 1097</b>	<b>CHAMPAGNE</b>	<b>DISTRICTS/FIRE PROTECT</b> Provides relative to the per diem paid to members of Vermilion Parish Fire Protection District No. 7
<b>HB 1051</b>	<b>SMITH, PATRICIA</b>	<b>DISTRICTS/DOWNTOWN DEVEL</b> Provides relative to the Downtown Development District of the city of Baton Rouge
<b>HB 909</b>	<b>BARROW</b>	<b>TRAFFIC/VIOLATIONS</b> Requires local governing authorities to report the number of traffic citations issued and revenue collected directly to the legislature
<b>HB 971</b>	<b>BARROW</b>	<b>TAX/LEASE</b> Authorizes East Baton Rouge parish to create an automobile rental tax district
<b>HB 961</b>	<b>BARROW</b>	<b>TAX/LEASE</b> Authorizes parishes to create an automobile rental tax district
<b>HB 924</b>	<b>BISHOP, WESLEY</b>	<b>DISTRICTS/ECONOMIC DEVEL</b> Creates the Downman Road Economic Development District in Orleans Parish
<b>HB 1117</b>	<b>BILLIOT</b>	<b>PROPERTY/VACANT SUBSTAND</b> Provides relative to the enforcement of certain liens
