HB 335	LORUSSO	DISTRICTS/SPECIAL Relative to the New Orleans City Park Taxing District, provides with respect to procedures relative to use of state sales tax increments for tax increment financing
HB 681	LEGER	ENERGY Provides relative to energy efficiency or renewable energy improvement loans
HB 1103	LEGER	DISTRICTS/SPECIAL Provides relative to the La. Sports and Entertainment District
HB 968	ARNOLD	TRAFFIC Prohibits an unpaid traffic citation that was issued by an automated traffic enforcement system from being sent to a collection agency
HB 973	HARRISON	DISTRICTS/HOSPITAL SERVC Creates a hospital service district
HB 1119	HARRISON	DISTRICTS/HOSPITAL SERVC Authorizes hospital service districts to operate facilities outside of the district's boundaries
HB 1137	SCHRODER	CIVIL SERVICE/FIRE & POL Provides relative to the filling of vacancies in certain positions in the classified police service
HB 1165	HAVARD	TAX/HOTEL OCCUPANCY Provides relative to hotel occupancy taxes levied and collected in certain municipalities
SB 315	AMEDEE	SUNSET LAW Re-creates the Department of Culture, Recreation and Tourism. (6/30/12)
SB 622	AMEDEE	LIEUTENANT GOVERNOR Authorizes the lieutenant governor to perform the duties, functions and responsibilities of the secretary of culture, recreation and tourism. (8/1/12)
SB 80	CORTEZ	LOCAL OFFICIALS Provides for the powers of the chief of police of Youngsville. (8/1/12)
SB 312	CORTEZ	LOCAL OFFICIALS Provides that the position of assistant police chief, relative to the towns of Broussard, Carencro, Scott and Youngsville, shall be in the unclassified service. (8/1/12)

- SB 617** **DONAHUE** **SPECIAL DISTRICTS** Changes the composition of the board of commissioners of the St. Tammany Parish Development District. (8/1/12)
- SB 98** **MORRELL** **FIRE PROTECTION** Provides for the expenditure of public funds by any fire protection district, municipal fire department, or volunteer fire department. (8/1/12)
- SB 361** **MORRELL** **SPECIAL DISTRICTS** Provides relative to 9-1-1 fees for the Orleans Communication District. (8/1/12)
- SB 630** **MORRELL** **LOCAL AGENCIES** Authorizes a fixed rate for emergency telephone service charges in St. Bernard Parish. (8/1/12)
- SB 496** **PERRY** **MUNICIPALITIES** Provides relative to the authority of the chief of police for the city of Kaplan and the position of assistant to the chief of police. (8/1/12)
