<b>HB 563</b>	<b>LANDRY, NANCY</b>	<b>CONTRACTS</b> Allows for cancellation of contracts with automatic renewal clauses
<b>HB 604</b>	<b>HARRISON</b>	<b>COMMERCE</b> Makes it an unfair trade practice to automatically bill a consumer, enter into automatic renewal contracts with a consumer, or bill a consumer for a third party without express written authorization
<b>HB 772</b>	<b>ARNOLD</b>	<b>EMERGENCY PREPAREDNESS</b> Provides relative to servitudes for utilities during times of emergency
<b>HB 823</b>	<b>GREENE</b>	<b>REAL ESTATE/APPRAISERS</b> Provides with respect to licensure requirements for appraisal management companies
<b>HB 1014</b>	<b>HOFFMANN</b>	<b>REAL ESTATE/APPRAISERS</b> Provides relative to appraisal management companies
<b>SB 128</b>	<b>CLAITOR</b>	<b>FEES/LICENSES/PERMITS</b> Provides relative to the Louisiana Professional Geoscience Practice Act. (gov sig)
<b>SB 316</b>	<b>MARTINY</b>	<b>FINANCIAL INSTITUTIONS</b> Provides for the use of a power of attorney at a financial institution. (8/1/12)
<b>SB 326</b>	<b>BROOME</b>	<b>LOANS</b> Requires the commissioner of the office of financial institutions to compile certain information from licensees under the Louisiana Deferred Presentment and Small Loan Act. (8/1/12)
<b>SB 360</b>	<b>MARTINY (TBA)</b>	<b>COMMERCIAL REGULATIONS</b> Provides for distribution and sale of marine products, motorcycles, all-terrain vehicles, and recreational vehicles. (8/1/12) <b>(Subject to Rule Suspension)</b>
<b>SB 389</b>	<b>MARTINY (TBA)</b>	<b>GOVERNMENTAL REGULATIONS</b> Requires the attorney general to regulate sweepstakes promotions and provides certain requirements and procedures. (8/1/12) <b>(Subject to Rule Suspension)</b>

**SB 399**      **WHITE (TBA)**

**UTILITIES** Provides relative to the powers and bylaws of electric cooperatives. (8/1/12) (**Subject to Rule Suspension**)

**SB 513**      **CROWE**

**ADMINISTRATION DIVISION** Prohibits the Department of Economic Development or the office of entertainment industry development from certifying certain film projects. (8/1/12)
