| SB 138 | ALLAIN | MOTOR CARRIERS Provides relative to special permits for vehicles hauling sugarcane. (8/1/12) |
| SB 396 | CROWE | PORTS/HARBORS/TERMINALS Provides for changes in the board membership of the Louisiana International Gulf Transfer and Terminal Authority. (gov sig) |
| SB 404 | MARTINY | PUBLIC CONTRACTS Provides relative to contracts by public entities. (8/1/12) |
| SB 436 | LONG | WATER/WATERWAYS Requires the Sabine River Authority to obtain legislative committee and certain local government approval for out-of-state water sales. (8/1/12) |
| SB 483 | PERRY | MOTOR VEHICLES Allows golf carts to be driven by licensed and insured drivers on the roadways of Palmetto Island State Park. (8/1/12) |
| SB 486 | PERRY | MOTOR VEHICLES Provides relative to reinstatement of driving privileges under certain circumstances for persons convicted of certain |

offenses involving operating a vehicle while intoxicated. (gov sig)

SB 488	PERRY	MOTOR VEHICLES Provides relative to eligibility for a restricted license by persons convicted of certain crimes involving operating a vehicle while intoxicated. (gov sig)
