<b>HB 93</b>	<b>THIERRY</b>	<b>COURTS/COURT COSTS</b> Authorizes an increase in court costs for the Opelousas City Court
<b>HB 112</b>	<b>HILL</b>	<b>COURTS/COURT COSTS</b> Authorizes any mayor's court within certain municipalities to increase court costs
<b>HB 117</b>	<b>HOWARD</b>	<b>COURTS/DISTRICT</b> Authorizes the 11 <sup>th</sup> JDC to provide for a reentry division of court
<b>HB 127</b>	<b>LORUSSO</b>	<b>MILITARY AFFAIRS</b> Provides with respect to the La. Code of Military Justice
<b>HB 195</b>	<b>CHANEY</b>	<b>INSURANCE/GROUP-SHERIFFS</b> Provides with respect to payment of insurance premiums for retired sheriffs and deputy sheriffs of the Richland Parish Sheriff's Office
<b>HB 212</b>	<b>BROSSETT</b>	<b>HOMELAND SECURITY</b> Provides relative to the creation of a statewide mapping and planning system for certain schools
<b>HB 244</b>	<b>LORUSSO</b>	<b>LAW ENFORCE/OFFICERS</b> Provides with respect to release of personal information of law enforcement officers
<b>HB 282</b>	<b>WILLMOTT</b>	<b>PARISH/JEFFERSON</b> Provides relative to appeals of certain administrative adjudication hearings in Jefferson Parish
<b>HB 295</b>	<b>JOHNSON</b>	<b>COURTS/MAYORS</b> Authorizes an increase in court costs in the mayor's court for the town of Mansura
<b>HB 307</b>	<b>LAMBERT</b>	<b>ENVIRONMENT/QUALITY DEPT</b> Provides for stays during appeals of certain decisions of the Department of Environmental Quality
<b>HB 312</b>	<b>LORUSSO</b>	<b>MILITARY AFFAIRS</b> Provides with respect to time limitations for the renewal of licenses under the Military Service Relief Act

<b>HB 313</b>	<b>HONORE</b>	<b>CRIMINAL/PROCEDURE</b> Provides for the assessment of a cost to reimburse the office of the constable of the city of Baton Rouge in the execution of certain bench warrants
<b>HB 332</b>	<b>GAROFALO</b>	<b>COURTS/COURT COSTS</b> Provides for an increase in court costs for justice of the peace courts
<b>HB 448</b>	<b>JAMES</b>	<b>CRIMINAL/PROCEDURE</b> Authorizes the designation of specialized divisions or sections in city or municipal courts
<b>HB 462</b>	<b>ARNOLD</b>	<b>ALCOHOLIC BEVERAGES</b> Provides relative to citizenship and residency requirements for manufacturer's permits
<b>HB 489</b>	<b>COX</b>	<b>ALCOHOLIC BEVERAGE PERMT</b> Provides for the expansion of certain permit authority for areas designated as local historic landmark districts
<b>HB 561</b>	<b>BURNS, TIM</b>	<b>CORONERS</b> Provides relative to the coroner of St. Tammany Parish
