<b>HB 240</b>	<b>HAVARD</b>	<b>PRIVATIZATION</b> Establishes the Privatization Review Act
<b>HB 377</b>	<b>LEGER (TBA)</b>	<b>TAX CREDITS</b> Establishes a registry for tax credits and provides relative to the period of time to report claims or a transfer to the registry ( <b>Subject to Rule Suspension</b> )
<b>HB 498</b>	<b>LANDRY, NANCY</b>	<b>CAMPAIGN FINANCE</b> Prohibits persons engaged in the private correctional facility business and related persons from giving campaign contributions in support of or opposition to certain officials and candidates
<b>HB 519</b>	<b>HENRY</b>	<b>PRIVATIZATION</b> Establishes the Privatization Review Act
<b>HB 531</b>	<b>HAVARD</b>	<b>EDUCATION/FINANCE</b> (Constitutional Amendment) Provides relative to increasing the financial burden of public school systems
<b>SB 1</b>	<b>CLAITOR</b>	<b>LEGISLATION</b> Constitutional amendment to prohibit legislation relative to state tax rebates from being considered during a regular session held in an even-numbered year. (2/3-CA13s1(A))
<b>SB 15</b>	<b>PERRY</b>	<b>REGISTRARS OF VOTERS</b> Authorizes the registrars of voters to make changes of address, changes of party affiliation or nonaffiliation and changes of name received prior to the close of the registration records for the general election. (gov sig)
<b>SB 20</b>	<b>ALLAIN</b>	<b>LOCAL FINANCE</b> Provides certain requirements for meetings at which consideration of or action upon proposals by political subdivisions to levy, increase, renew, or continue property or sales taxes, or authorize the calling of an election for submittal of such question to voters are scheduled. (8/1/13)
<b>SB 61</b>	<b>MORRISH</b>	<b>ETHICS</b> Provides for exceptions to the provisions of law relative to ethical standards for public servants. (8/1/13)

<b>SB 101</b>	<b>JOHNS (TBA)</b>	<b>LIFE INSURANCE</b> Provides with respect to life insurance reserves. (1/1/14) <b>(Subject to Rule Suspension)</b>
<b>SB 129</b>	<b>SMITH, JOHN</b>	<b>ETHICS</b> Provides for an exception to the definition of "public employee" relative to the Code of Governmental Ethics. (8/1/13)
<b>SB 148</b>	<b>LAFLEUR</b>	<b>ETHICS</b> Provides an exception to the Code of Governmental Ethics for persons whose public service is limited to a contract providing professional services as a CPA. (gov sig)
<b>SB 191</b>	<b>MORRELL</b>	<b>ELECTION DAYS</b> Changes the dates for municipal and parochial elections, inaugurations, and qualifying periods, in certain parishes. (see Act)
<b>SB 212</b>	<b>SMITH, GARY</b>	<b>PUBLIC MEETINGS</b> Requires proceedings to be video or tape recorded, filmed, or broadcast live for certain nonelected boards and commissions. (gov sig)
