HB 655	MACK	MOTOR CARRIERS Requires a person applying for a commercial driver's license to provide a current medical examiner's certificate
HB 860	MACK	MOTOR CARRIERS Provides for the registration expiration date for certain commercial trucks and trailers
HB 898	GAINES	PORTS/SOUTH LOUISIANA Increases the membership of the Port of South Louisiana Commission
HB 960	GAROFALO	MTR VEHICLE/VIOLATIONS Provides for notifications to habitual offenders
HB 963	GAROFALO	MTR VEHICLE/DRIVER LIC Prohibits novelty or unofficial credentials intended to simulate valid state or federal credentials
HB 967	GAROFALO	MTR VEHICLE/DRIVER LIC Provides for international driver's licenses

HB 106	LOPINTO	TRANSPORTATION Provides relative to the improper display of license plates
HB 136	GUINN	HIGHWAYS Provides for the designation of the Flyway Byway as a Louisiana Byway
HB 220	THIBAUT	MTR VEHICLE/VIOLATIONS Specifies that the violation of failing to obtain a current and valid motor

vehicle inspection certificate within a specified period of time constitutes a secondary offense

HB 316	BURFORD	MTR VEHICLE/INSPECTION Exempts single axle two-wheel trailers from motor vehicle inspection requirements
HB 347	BADON	MOTOR VEHICLES Exempts boat trailers from the requirement to have inspection stickers
HB 386	HAVARD	MTR VEHICLE/INSPECTION Provides relative to required documents for trailer inspections
HB 419	MONTOUCET	DISTRICTS/DRAINAGE Provides relative to access to public drainage for maintenance purposes
HB 543	ADAMS	MTR VEHICLE/EMERGENCY Allows all fire department vehicles to be equipped with blue colored electric lights
HB 793	ST. GERMAIN	WATER/RESOURCES Provides for the membership of the Capital Area Groundwater Commission
HB 929	BADON	MOTOR VEHICLES Provides relative to the booting of motor vehicles parked on private property
