Provides relative to membership in state retirement systems for certain new hires

\_\_\_\_\_ **HB 86**    **IVEY**    **RETIREMENT/COLAS** Provides for application of a portion of state retirement system investment returns to system debt and increases the threshold that must be met prior to funding state retirement system experience accounts
