_____	<b>HB 258</b>	<b>JOHNSON, M.</b>	<b>MEDICAID</b> Provides relative to grounds and procedures for denial or revocation of Medicaid provider enrollment and eligibility for health facility licensure
_____	<b>HB 496</b>	<b>MORRIS, JAY</b>	<b>ACUPUNCTURISTS</b> Provides for the practice of acupuncture
_____	<b>HB 557</b>	<b>MORRIS, JAY</b>	<b>ACUPUNCTURISTS</b> Provides for the licensing of acupuncturists
_____	<b>HB 606</b>	<b>HOFFMANN</b>	<b>FUNDS/FUNDING</b> Prohibits entities that perform abortions from receiving public funding for any purpose
_____	<b>HB 718</b>	<b>HUNTER</b>	<b>HEALTH CARE/FACILITIES</b> Requires certain licensed medical facilities to be equipped with backup generators
_____	<b>HB 732</b>	<b>ABRAMSON</b>	<b>HEALTH CARE/FACILITIES</b> Requires all private and public facilities to report psychiatric inpatient and crisis stabilization beds at least once daily
_____	<b>HB 792</b>	<b>ADAMS</b>	<b>MASSAGE THERAPISTS</b> Provides relative to the regulation of massage therapists
_____	<b>HB 815</b>	<b>STOKES</b>	<b>HUMAN REMAINS</b> Prohibits post-abortion harvesting of fetal remains and requires burial or cremation of such remains

_____	<b>HB 934</b>	<b>HOFFMANN</b>	<b>BOARDS/COMMISSIONS</b> Provides relative to judicial review of administrative decisions rendered by the La. State Board of Dentistry
_____	<b>HB 1019</b>	<b>EDMONDS</b>	<b>ABORTION</b> Prohibits abortion based on genetic abnormality
_____	<b>HB 1071</b>	<b>JONES</b>	<b>HEALTH</b> Creates the office of state surgeon general
_____	<b>HB 1081</b>	<b>JOHNSON, M.</b>	<b>ABORTION</b> Provides for the Unborn Child Protection from Dismemberment Abortion Act
_____	<b>HCR 34</b>	<b>HOFFMANN</b>	<b>LEGISLATIVE AGCY/LAW INST</b> Requests completion of a study regarding continuing contact by parents and other relatives with children in need of care
