V to call a convention of the states to propose U.S. constitutional amendments to impose fiscal restraints on the federal government, limit federal government power, and provide for term limits for federal officials and members of congress

_____	HB 1102	BISHOP, S.	CHILDREN Provides relative to gestational carriers
_____	SB 64	LUNEAU	ETHICS Provides an exception for an attorney serving on a Civil Service Commission. (8/1/16)
_____	SB 68	WALSWORTH	LEGISLATIVE AGENCIES Provides relative to the Legislative Youth Advisory Council. (gov sig)
_____	SB 151	CLAITOR	DISTRICT ATTORNEYS Repeals certain provisions declared unconstitutional that regard attorney fees in lawsuits filed against public officials. (8/1/16)
_____	SB 222	CLAITOR	PUBLIC RECORDS Provides that certain records in the custody of the Louisiana State Licensing Board for Contractors are exempt from the Public Records Law. (8/1/16)
