_____	SB 396	JOHNS	MUNICIPALITIES Provides relative to promotional seniority in the Lake Charles Police Department for officers who have been deployed. (8/1/16)
_____	SB 457	LAFLEUR	SCHOOLS Authorizes the Avoyelles Parish School Board to levy and collect an additional sales tax, subject to voter approval. (gov sig)
