_____	HB 119	IVEY	BUDGETARY PROCEDURES Establishes the Louisiana Fiscal Transparency Website as a source of information for state expenditures
_____	HB 224	MORENO	FUNDS/FUNDING Dedicates state sales and use taxes levied on hotel rooms in residences in Orleans Parish into the New Orleans Quality of Life Fund
_____	HB 236	SHADOIN	FUNDS/FUNDING (Constitutional Amendment) Eliminates certain constitutional dedication of revenue and certain treasury funds
_____	HB 294	BACALA	FUNDS/FUNDING Dedicates a portion of the state sales and use taxes on sales of motor vehicles for transportation projects

_____	HB 398	GAROFALO	BUDGETARY PROCEDURES Requires the budgeted amount and authorized positions for the current year to be placed adjacent to the appropriation and authorized positions for the next year in the General Appropriation Bill and other appropriation bills
_____	HB 457	HARRIS, L.	REVENUE SHARING (Constitutional Amendment) Phases out the state revenue sharing fund
_____	HB 530	BROADWATER	FUNDS/FUNDING Establishes the Louisiana Headquartered Motion Picture Production Cooperative Endeavor Program and the Louisiana Headquartered Motion Picture Production Fund
_____	HB 541	CARTER, S.	STUDENTS Provides relative to early graduation from high school including incentives for students and savings used for certain other educational purposes
