_____	<b>HB 367</b>	<b>IVEY</b>	<b>TAX EXEMPTIONS</b> Repeals authority for tax exemption contracts to be granted by the Board of Commerce and Industry for manufacturing establishments, corporate headquarters, and warehousing and distribution establishments
_____	<b>HB 368</b>	<b>IVEY</b>	<b>TAX/AD VALOREM TAX</b> Provides for the classification of and applicable fair market value percentages for property subject to ad valorem taxation
_____	<b>HB 369</b>	<b>IVEY</b>	<b>TAX/AD VALOREM TAX</b> (Constitutional Amendment) Provides relative to the ad valorem tax exemption for new or existing manufacturing establishments
_____	<b>HB 635</b>	<b>IVEY</b>	<b>TAX/SALES-USE-EXEMPT</b> Provides with respect to sales tax holidays
_____	<b>SB 10</b>	<b>MILLS</b>	<b>MUNICIPALITIES</b> Authorizes the St. Martin Parish Assessment District to provide for an automobile expense allowance for the assessor. (gov sig)
_____	<b>SB 25</b>	<b>MORRELL</b>	<b>TAX/INCOME/PERSONAL</b> Sunsets the individual income tax education credit. (gov sig)
_____	<b>SB 30</b>	<b>MORRELL</b>	<b>TAX/SALES</b> Extends the Tax Free Shopping Program set to terminate on July 1, 2017. (gov sig)

_____	<b>SB 61</b>	<b>ALLAIN</b>	<b>TAX/AD VALOREM</b> Constitutional amendment to authorize local economic development authorities or districts to enter into contracts to exempt offshore vessels from ad valorem taxation. (2/3 - CA13s1(A))
_____	<b>SB 79</b>	<b>LUNEAU</b>	<b>TAX/TAXATION</b> Removes the June 30, 2018, sunset provision and makes permanent reductions to certain income and corporation franchise tax credits. (gov sig)
_____	<b>SB 95</b>	<b>MORRISH</b>	<b>TAX EXEMPTIONS</b> Changes the rebate for donations to certain school tuition organizations to a nonrefundable income tax credit. (gov sig)
_____	<b>SB 97</b>	<b>FANNIN</b>	<b>TAX EXEMPTIONS</b> Provides relative to the sales and use tax exemption for feed, seed, and fertilizer used by commercial farmers. (1/1/18)
_____	<b>SB 140</b>	<b>WALSWORTH</b>	<b>TAX EXEMPTIONS</b> Constitutional Amendment to exempt from ad valorem taxation certain property delivered to a construction site. (2/3 - CA13s1(A))
_____	<b>SB 172</b>	<b>MORRELL</b>	<b>TAX/TAXATION</b> Terminates certain tax credits as of January 1, 2019. (gov sig)
_____	<b>SB 177</b>	<b>MORRELL</b>	<b>TAX/TAXATION</b> Provides relative to the Motion Picture Tax Credit Program for the withholding of income tax for performance of services on a state-certified production. (gov sig)
_____	<b>SB 178</b>	<b>MORRELL</b>	<b>TAX/TAXATION</b> Establishes termination dates for certain tax credits and incentive programs administered by the Department of Economic Development. (gov sig)
_____	<b>SB 180</b>	<b>MORRELL</b>	<b>TAX EXEMPTIONS</b> Restores the sales and use tax exemption for medical devices. (gov sig)
_____	<b>SB 182</b>	<b>MORRELL</b>	<b>TAX/AD VALOREM</b> Provides for the tax credit for ad valorem taxes paid on inventory by taxpayers included in one consolidated federal income tax return. (gov sig)
_____	<b>SB 183</b>	<b>MORRELL</b>	<b>TAX/TAXATION</b> Provides termination dates for certain tax incentive and rebate programs. (gov sig)
_____	<b>SB 241</b>	<b>JOHNS</b>	<b>TAX EXEMPTIONS</b> Restores the sales and use tax exemption for dental devices. (gov sig)
_____	<b>SB 243</b>	<b>PEACOCK</b>	<b>TAX/TAXATION</b> Provides relative to the tax credit for conversion of alternative fuel vehicles. (gov sig)

**TAX/TAXATION** Provides for an annual cap and a termination date for the musical and theatrical production income tax credit. (7/1/17)
