_____	HB 873	HILFERTY	FUNDS/FUNDING Dedicates any new revenue realized as a result of the enactment of legislation relative to sports betting and other forms of gaming to the La. Early Childhood Education Fund
_____	SB 400	HEWITT	FUNDS/FUNDING Provides for certain funds in the state treasury and the powers, duties, functions, and responsibilities of the Dedicated Fund Review Subcommittee of the Joint Legislative Committee on the Budget. (See Act)
