_____	<b>HB 402</b>	<b>SMITH, P.</b>	<b>VOTING/REGISTRATION</b> Provides relative to registration and voting by a person convicted of a felony
_____	<b>HB 435</b>	<b>LANDRY, T.</b>	<b>LEGISLATORS</b> (Constitutional Amendment) Provides that the legislature shall provide by law for an independent compensation commission to examine, evaluate, and establish the compensation, benefits, and expense allowances for members of the legislature
_____	<b>HB 447</b>	<b>IVEY</b>	<b>LEGISLATIVE BUDG CONTROL</b> Provides relative to legislative obligations, expenditures, or disbursements of funds or contracts

_____	<b>HB 504</b>	<b>FRANKLIN</b>	<b>REAPPORTIONMENT</b> Creates and provides for the Reapportionment Transparency Act
_____	<b>HB 527</b>	<b>COUSSAN</b>	<b>VOTERS/VOTING</b> Prohibits persons convicted of certain crimes from registering or voting while under an order of imprisonment for conviction of a felony
_____	<b>HB 563</b>	<b>MILLER, G.</b>	<b>ELECTION CODE</b> Makes revisions to the Louisiana Election Code
