HB 57	MAGEE	TAX/SALES & USE (Constitutional Amendment) Authorizes the legislature to provide by law for the collection of all sales and use taxes imposed by any taxing authority in the state
HB 529	FOIL	ECONOMIC DEVELOPMENT Provides relative to the Department of Economic Development and the Board of Commerce and Industry
HB 530	HODGES	TAX CREDITS Requires certain taxpayers claiming the earned income tax credit to provide the Dept. of Revenue with certain information regarding residency of dependents
HB 542	CARTER, S.	TAX/EXCISE Increases the per gallon excise tax on gasoline, diesel, and certain special fuels and levies an excise tax on electric and hybrid vehicles
HB 595	WRIGHT	TAX CREDITS Establishes an income tax credit for contributions to certain foster care charitable organizations
HB 607	FOIL	TAX CREDITS Provide for the public-private partnership investment program and authorizes the issuance of tax credits
SB 5	MORRELL	TAX/SALES Exempts diapers and feminine hygiene products from sales and use tax. (1/1/21)
SB 33	THOMPSON	SPECIAL DISTRICTS Authorizes expansion of scope of projects and extension of use of state sales tax for certain tax increment financing districts. (8/1/19)
SB 37	PEACOCK	TAX/TAXATION Authorizes the office of debt recovery to collect delinquent debts on behalf of local government subdivisions. (8/1/19)
SB 59	LONG	TAX/INCOME/PERSONAL Adds physician assistants to persons eligible for reduction to their individual income tax. (8/1/19)

- SB 79** **CARTER, T.** **TAX/AD VALOREM** Constitutional amendment to authorize ad valorem tax exemptions in Orleans Parish to promote affordable housing. (2/3 - CA13s1(A))
- SB 80** **CARTER, T.** **TAX/AD VALOREM** Provides relative to the ad valorem tax exemption in Orleans Parish for affordable housing. (See Act)
- SB 198** **PEACOCK** **TAX/SALES** Provides for administration, disposition, enforcement, and adjudication of state and local taxes and for the Board of Tax Appeals. (gov sig)
- SB 225** **FANNIN** **TAX EXEMPTIONS** Exempts certain purchases by student farmers from state sales and use tax. (8/1/19)
- SB 235** **MORRELL** **TAX/TAXATION** Repeals unused tax credits. (gov sig)
