 HCR 58	MIGUEZ	GOVERNOR Suspends certain provisions of Title 29 of the La. Revised Statutes relative to the governor's authority to declare an emergency, disaster, or public health emergency
 HCR 30	DWIGHT	VOTERS/VOTING Suspends certain provisions of law relative to the time by which a voter must be registered as affiliated with a particular political party to be eligible to vote for candidates for membership on that party's committees
 HB 798	DWIGHT	PUBLIC MEETINGS Authorizes public bodies to allow members to participate and vote electronically during certain states of emergency subject to certain conditions
 HB 868	IVEY	LEGISLATIVE AFFAIRS Provides relative to the continuity of the legislature in times of emergency or disaster
 HB 497	IVEY	LEGISLATIVE AUDITOR Requires each auditee in state government to provide the legislative auditor with direct access to data
 HB 636	IVEY	LEGISLATIVE COMMITTEES Creates and provides for the Joint Legislative Committee on Technology and Cybersecurity
 HB 685	IVEY	PUBLIC RECORDS Provides relative to interagency data sharing
 HB 6	MILLER, G.	STATE AGENCIES Provides relative to reports by executive branch agencies

 HB 110	MILLER, G.	ELECTIONS/CANDIDATES Provides relative to methods of service of process regarding actions objecting to candidacy and contesting an election
 HB 486	MILLER, G.	VOTERS/VOTING Provides standards for the counting and tabulation of irregularly marked paper ballots
 HB 248	HARRIS, LANCE	STATE DEPARTMENT Provides relative to overtime compensation of Department of State employees for election-related activities during certain time periods
 HB 81	TURNER	ETHICS/NEPOTISM Provides an exception to allow immediate family members of a coach of a collegiate athletic program to be employed on the staff of that program
 HB 755	JORDAN	ETHICS/CODE Provides an ethics exception to allow legislators, statewide elected officials, specified public servants, immediate family members, and related legal entities to enter into contracts to be a public defender
 HB 481	MAGEE	CRIMINAL/JUSTICE Requires the uniform reporting by entities that assess, collect, or receive revenue from pre- or post-adjudication costs, fines, and fees
