_____	HB 292	RISER	TAX/CORP INCOME Repeals the income tax deduction for federal income taxes paid for purposes of calculating corporation income tax
_____	HB 293	RISER	TAX/CORP INCOME Provides for the rate of corporation income tax
_____	HB 369	IVEY	TAX/INCOME TAX (Constitutional Amendment) Provides for a flat tax on individual income and eliminates the mandatory income tax deduction for federal income taxes paid for purposes of computing income taxes

B. Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
