_____	HB 72	COUSSAN	BUDGETARY CONTROLS Authorizes the secretary of the Department of Environmental Quality to establish a voluntary environmental self-audit program
_____	HB 120	NEWELL	PUBLIC RECORDS Provides that airport facility plans are confidential
_____	HB 128	ZERINGUE	FISCAL CONTROLS Provides relative to the powers and duties of the Cash Management Review Board with respect to financial security and cybersecurity plans and procedures adopted by state agencies, including the assessment and deployment of such plans and procedures
_____	HB 185	OWEN, CHARLES	POLICE/STATE Provides relative to records maintained by the Louisiana State Analytical and Fusion Exchange
_____	HB 438	MIGUEZ	PUBLIC RECORDS Authorizes a custodian to require a requestor of a public record to provide sufficient proof of identity
_____	HB 456	EDMONDS	ECONOMIC DEVELOPMENT Provides relative to protection of employee data submitted to Louisiana Economic Development as a condition of business incentive program verification
_____	HB 648	DESHOTEL	TELECOMMUNICATIONS Establishes a grant program to be administered by the office of broadband development and connectivity in the division of administration

B. Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
