 HB 452	DAVIS	<b>DOMESTIC ABUSE</b> Creates a domestic violence fatality review team within the Louisiana Department of Health
 HB 607	DESHOTEL	<b>COMMERCIAL REGULATIONS</b> Provides relative to the joint legislative committee on technology and cybersecurity
 HCR 3	EDMONDS	<b>JOINT RULES</b> Authorizes a member of the Joint Medicaid Oversight Committee to request the presiding officer of his house to designate another member to serve as his proxy at a meeting of the committee that the member is unable to attend

 HCR 57	IVEY	<b>LEGISLATIVE AUDITOR</b> Requests the division of administration to provide electronic access to a synchronized copy of the data points in the LaGov Enterprise Resource Planning system to the legislative auditor
 HCR 60	CREWS	<b>ELECTIONS</b> Requests the secretary of state to study the implementation of a notification system to alert a voter regarding the status of his vote

Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
