INSTRUMENTS TO BE HEARD:

<b>HR 130</b>	<b>DEWITT</b>	<b>WILDLIFE/MGT AREAS</b> Urges and requests the La. Dept. of Wildlife and Fisheries to find ways to increase youth use of Wildlife Management Areas
<b>HCR 49</b>	<b>THOMPSON</b>	<b>CONSERVATION</b> Commends and expresses support for the cooperative conservation and management work being carried out by agricultural conservation partnerships in the state
<b>SCR 25</b>	<b>HODGES</b>	<b>FLOODS/FLOODING</b> Creates the Comite River Diversion Canal/Amite River Basin Task Force.
<b>SB 411</b>	<b>KLEINPETER</b>	<b>WILDLIFE/FISHERIES DEPT</b> Requires the Department of Wildlife & Fisheries to notify applicants for recreational fishing and hunting licenses of the option to become an organ and tissue donor and make an organ donation. (8/1/24)
<b>SB 418</b>	<b>LAMBERT</b>	<b>PUBLIC LANDS</b> Authorizes the transfer of certain state property in Ascension Parish. (gov sig)
<b>SB 432</b>	<b>EDMONDS</b>	<b>CONSERVATION</b> Provides relative to the capital area groundwater conservation district. (8/1/24)
<b>SB 441</b>	<b>HARRIS, JIMMY</b>	<b>PUBLIC LANDS</b> Provides for the transfer of certain state property in Orleans Parish. (gov sig)
