HB 294	BAGLEY	TAX/SEVERANCE TAX (Constitutional Amendment) Provides relative to severance tax revenues remitted to parishes in which the associated severance occurs
HB 295	TARVER, PHILLIP	APPROPRIATIONS (Constitutional Amendment) Limits the amount of State General Fund (Direct) revenues that may be appropriated in a fiscal year for recurring expenses and restricts use of such revenues above that limit
HB 473	EMERSON	FUNDS/FUNDING (Constitutional Amendment) Provides relative to the application of state monies to the unfunded accrued liability of the Teachers' Retirement System of La.
HB 575	VENTRELLA	ABORTION Provides relative to liability for the unlawful termination of a pregnancy
SB 116	KLEINPETER	NOTARIES Provides for reciprocal notarial authority of notaries qualified in St. Martin Parish and St. Landry Parish. (8/1/25)

<b>HB 98</b>	<b>YOUNG</b>	<b>PROPERTY/EXPROPRIATION</b> Authorizes the parish of Lincoln to expropriate property by a declaration of taking
<b>HB 140</b>	<b>FARNUM</b>	<b>PROPERTY/IMMOVABLE</b> Provides relative to residential home improvements
<b>HB 217</b>	<b>MENA</b>	<b>CIVIL/PROCEDURE</b> Provides for legislative continuances and extensions of time for legislators and legislative employees
<b>HB 247</b>	<b>CHENEVERT</b>	<b>PROPERTY/EXPROPRIATION</b> Provides relative to the expropriation of blighted property in East Baton Rouge Parish and the city of Baton Rouge
<b>HB 287</b>	<b>BACALA</b>	<b>INSURANCE</b> Authorizes certain out-of-state insurance companies to apply respective state laws to claims of Louisiana residents
<b>HB 289</b>	<b>CARRIER</b>	<b>LIABILITY/CIVIL</b> Provides relative to civil liability of firearm and ammunition manufacturers and distributors
<b>HB 371</b>	<b>AMEDEE</b>	<b>RELIGIOUS ORGANIZATIONS</b> Provides relative to the free exercise of religion
<b>SB 75</b>	<b>MILLER, G.</b>	<b>CIVIL PROCEDURE</b> Provides for legislative continuances and extensions of time for legislators and legislative employees. (gov sig)
