| HB 751 | TAYLOR | INSURANCE Requires insurers or business entities promoting term life insurance policies to provide certain notices to applicants |
| HB 771 | TAYLOR | INSURANCE/HEALTH Provides relative to Medicare as the secondary payer for retirees with employer-sponsored health insurance |
| HB 826 | GREEN | INSURANCE Provides relative to referrals for sales of insurance |

| HB 866 | DEWITT | INSURANCE CLAIMS Prohibits pharmacy benefit managers and managed care plans from reducing pharmacy reimbursements |
| HB 870 | TURNER | INSURANCE/HEALTH Provides relative to formulary placement and cost-sharing requirements for certain generic drugs and biosimilars |
| HB 938 | TURNER | INSURANCE/HEALTH Provides relative to pharmacy benefit managers |
