<b>HB 624</b>	<b>JOHNSON, MIKE</b>	<b>SCHOOLS</b> Provides relative to emergency operations plans at public schools
<b>HB 1022</b>	<b>JACKSON</b>	<b>HEALTH/SCHOOL CLINICS</b> Provides relative to health services provided to students
<b>HB 1084</b>	<b>TURNER</b>	<b>STUDENT/TUITION</b> Provides relative to tuition and mandatory fees for public postsecondary education institutions
<b>HB 1203</b>	<b>EDMONSTON</b>	<b>EDUCATION</b> Provides relative to parent-driven learning cooperatives
<b>SB 82</b>	<b>MIZELL</b>	<b>SCHOOLS</b> Provides for a five-day school week for public schools with exceptions. (gov sig)
<b>SB 206</b>	<b>MILLER, G.</b>	<b>HEALTH SERVICES</b> Provides for blood pressure testing in schools. (8/1/26)
<b>SB 305</b>	<b>EDMONDS</b>	<b>COLLEGES/UNIVERSITIES</b> Requires the Board of Regents, Louisiana Works, and other state agencies to develop a publicly available statewide dashboard for career alignment that provides information related to educational and career opportunities. (8/1/26)
<b>SB 376</b>	<b>MIZELL</b>	<b>SECONDARY EDUCATION</b> Provides for the Learn and Earn Act. (gov sig)
<b>SB 441</b>	<b>MIZELL</b>	<b>STUDENTS</b> Provides relative to programs for prekindergarten-aged children. (gov sig)
