Dear Members of the Legislature:

Enclosed you will find a ballot requesting your vote to make available for appropriation \$28,164,341 from the Budget Stabilization Fund ("Rainy Day Fund") to satisfy that portion of the Four Hundred Eighty-Seven Million Two Hundred Seventy-Seven Thousand Five Hundred Eighteen Dollars (\$487,277,518) deficit that was recognized by the Revenue Estimating Conference on November 16, 2015, and certified by the Joint Legislative Committee on the Budget and received by my office on November 20th.

As you know, I have already ordered an expenditure and hiring freeze during this fiscal year (BJ 2015-11) in order to achieve the \$18,840,452 savings directed in the preamble of Act 16 of the 2015 Regular Session for last fiscal year.

As authorized by R.S. 39:75(C)(1)(a), I have utilized my unilateral interim budget balancing powers to reduce the projected deficit by \$263,964,722. After utilizing that authority, \$223,312,796 remained of the projected deficit which must be eliminated. Therefore, I directed the Commissioner of Administration to present a plan to eliminate this remaining amount of the projected deficit to the Joint Legislative Committee on the Budget for its approval, which it also did on November 20th. Of that amount, \$28,164,341 is needed from the Rainy Day Fund in order to avoid cuts to higher education and other critical state services.

The Constitution requires the approval of two-thirds vote of each house of the legislature for the Rainy Day Fund to be accessed. Your ballot must be returned within 15 days to be counted, and I urge you vote in favor of this request.
