IV. DISCUSSION

House Bill No. 818 by Representative St. Germain

House Bill No. 818 creates the Louisiana Fire and Emergency Training Commission within Louisiana State University and provides for its powers and duties.

Representative St. Germain presented the bill to the committee. She was accompanied by Mr. H. Butch Browning, State Fire Marshall, who presented information in support of the bill. Also supporting the bill was Mr. Boyd Westbrook, representing the Louisiana Fire Chiefs Association, 6035 Hagerstown, Baton Rouge, LA. Available to present information was Mr. Mike Martin, chancellor, Louisiana State University-Baton Rouge, (225) 921-0021.

Representative Carter announced that amendments were pending. Ms. Nancy Jolly, committee legislative analyst, explained that the amendments made technical changes only. Representative Carter offered the amendments and moved that they be adopted. There was no objection, and the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Hollis, Jefferson, Landry, Price, Schroder, Shadoin, Patricia Smith, Thompson, and Alfred Williams voted yea.

Representative St. Germain closed on the bill.

Representative Champagne moved that House Bill No. 818 be reported with amendments. There was no objection, and House Bill No. 818 was reported with amendments by a vote of 15 yeas and 0 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Hollis, Jefferson, Landry, Price, Schroder, Shadoin, Patricia Smith, Thompson, and Alfred Williams voted yea.

House Bill No. 833 by Representative Norton

House Bill No. 833 provides for early dismissal from public elementary and secondary schools under certain conditions.

Representative Carter announced that the author of the legislation has requested that it be voluntarily deferred. Representative Carter moved that action on House Bill No. 833 be voluntarily deferred. There was no objection, and the motion passed by a vote of 15 yeas and 0 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Hollis, Jefferson, Landry, Price, Schroder, Shadoin, Patricia Smith, Thompson, and Alfred Williams voted yea.

House Bill No. 834 by Representative Norton

House Bill No. 834 eliminates provisions relative to LEAP, iLEAP, end-of-course testing, and the graduate exit exam for students in public schools.

Representative Carter announced that the author of the legislation requested that it be voluntarily deferred. Representative Carter moved that action on House Bill No. 834 be voluntarily deferred. There was no objection, and the motion passed by a vote of 15 yeas and 0 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Hollis, Jefferson, Landry, Price, Schroder, Shadoin, Patricia Smith, Thompson, and Alfred Williams voted yea.

House Bill No. 525 by Representative Barrow

House Bill No. 525 requires public high school students to perform community service as a prerequisite for graduation.

Representative Barrow asked that House Bill No. 525 be voluntarily deferred at this time.

Representative Carter moved that action on House Bill No. 525 be voluntarily deferred. There was no objection, and the motion passed by a vote of 15 yeas and 0 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Hollis, Jefferson, Landry, Price, Schroder, Shadoin, Patricia Smith, Thompson, and Alfred Williams voted yea.

House Bill No. 269 by Representative Barrow

House Bill No. 269 provides relative to education of children in foster care.

Representative Barrow presented the bill to the committee. Representative Carmody moved that House Bill No. 269 be placed on the Local and Consent calendar. There was no objection, and House Bill No. 269 was placed on the Local and Consent calendar by a vote of 15 yeas and 0 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Hollis, Jefferson, Landry, Price, Schroder, Shadoin, Patricia Smith, Thompson, and Alfred Williams voted yea.

House Bill No. 100 by Representative Edwards

House Bill No. 100 requires approval by the House and Senate education committees of the value-added teacher assessment model prior to implementation of certain evaluation program requirements.

Representative Edwards presented the bill to the committee. Representative Edwards closed on the bill.

Representative Edwards moved that House Bill No. 100 be reported favorably. Representative Schroder offered a substitute motion that action on House Bill No. 100 be involuntarily deferred. Representative Edwards objected and the secretary called the roll. The substitute motion that action on House Bill No. 100 be involuntarily deferred passed by a vote of 11 yeas and 7 nays. Representatives Broadwater, Henry Burns, Carmody, Carter, Champagne, Henry, Hollis, Landry, Schroder, Shadoin, and Thompson voted nay, and Representatives Wesley Bishop, Edwards, Jefferson, Price, Richard, Patricia Haynes, and Alfred Williams voted yea.

Senate Bill No. 581 by Senator Appel

Senate Bill No. 581 provides for the Louisiana Early Childhood Education Act.

Representative Carter presented the bill on behalf of Senator Appel. Ms. Stafford Palmieri, policy director, Office of Governor Bobby Jindal, 4th Floor, State Capitol, Baton Rouge, LA, (225) 342-7015, accompanied him to present highlights of the bill and answer questions from committee members.

The persons listed in the attached were also in support of the legislation or were present to provide information, if requested. (See Attachment D)

Representative Henry moved that Senate Bill No. 581 be reported favorably. There was no objection, and Senate Bill No. 581 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Broadwater, Carmody, Carter, Champagne, Henry, Hollis, Jefferson, Landry, Price, Shadoin, and Thompson voted yea.
