IV. DISCUSSION

House Bill No. 964 by Representative Fannin

House Bill No. 964 provides for the merger of Louisiana Tech and Louisiana State University at Shreveport.

Representative Fannin presented the bill to the committee. He was accompanied by Representative Carmody and Dr. Phillip Rozeman, representing the Shreveport-Bossier Imperative, 510 Longleaf Rd., Shreveport, LA, (318) 426-7401, who presented information and answered questions from committee members.

Representative Carter announced that amendments were pending. Representative Carmody presented the amendments that would provide as follows:

- (1) Adds proposed law provisions relative to the responsibilities of the Louisiana Community and Technical College System Board of Supervisors and the Southern University Board of Supervisors to establish branch campuses at Louisiana State University at Shreveport.
- (2) Adds proposed law provisions relative to the postsecondary education delivery system for the Northwest Region and provisions relative to the establishment and duties of the implementation group.

Representative Carmody offered the amendments and moved that they be adopted. There was no objection, and the amendments were adopted by a vote of 12 yeas and 0 nays. House Bill No. 192 by Representative Richard

House Bill No. 192 provides relative to extended sick leave for teachers, school bus operators, and other school employees.

Representative Richard presented the bill to the committee. Representative Price offered a motion to involuntarily defer House Bill No. 192 to which there were no objections. The motion to involuntarily defer House Bill No. 192 passed by a vote of 16 yeas and 0 nays. Representatives Bishop, Broadwater, Henry Burns, Carmody, Carter, Champagne, Edwards, Henry, Hollis, Jefferson, Nancy Landry, Price, Richard, Patricia Smith, Thompson, and Alfred Williams voted yea.

House Bill No. 1122 by Representative James

House Bill No. 1122 provides relative to salary supplements for public school educational diagnosticians.

House Bill No. 1127 by Representative Barrow

House Bill No. 1127 provides relative to salary supplements for school psychologists.

House Bill No. 820 by Representative Patricia Smith

House Bill No. 820 requires rather than authorizes sex education instruction in public schools.

Representative Smith presented the bill to the committee.

Representatives Wesley Bishop, Broadwater, Carmody, Edwards, Jefferson, Nancy Landry, Price, Patricia Smith, and Alfred Williams voted yea, and Representatives

Henry Burns, Carter, Champagne, Henry, Hollis, Richard, Schroder, Shadoin, and Thompson voted nay.

Representative Champagne moved that action on House Bill No. 820 be voluntarily deferred. Representative Price objected, and the secretary called the roll. The motion that action on House Bill No. 820 be voluntarily deferred failed by a vote of 7 yeas and 11 nays. Representatives Henry Burns, Champagne, Henry, Hollis, Richard, Shadoin, and Thompson voted yea, and Representatives Wesley Bishop, Broadwater, Carmody, Carter, Edwards, Jefferson, Nancy Landry, Price, Schroder, Patricia Smith, and Alfred Williams voted nay.
