III. DISCUSSION OF LEGISLATION

House Bill No. 968 by Representative Arnold

Chairman Girod Jackson III stated that House Bill No. 968, which prohibits an unpaid traffic citation that was issued by an automated traffic enforcement system from being sent to a collection agency, had been voluntarily deferred by the author.

Mr. Ty Bromell, representing the Police Jury Association, 707 North 7th Street, Baton Rouge, LA 70802, (225) 343-2835, was present in opposition to the bill.

House Bill No. 973 by Representative Harrison

Chairman Girod Jackson III stated that House Bill No. 973, which creates a hospital service district, had been voluntarily deferred by the author.

House Bill No. 1137 by Representative Schroder

Chairman Girod Jackson III stated that House Bill No. 1137, which provides relative to the filling of vacancies in certain positions in the classified police service, had been voluntarily deferred by the author.

Chairman Girod Jackson III stated that House Bill No. 1165, which provides relative to hotel occupancy taxes levied and collected in certain municipalities, had been voluntarily deferred by the author.

House Bill No. 1119 by Representative Harrison

The author presented House Bill No. 1119, which authorizes hospital service districts to operate facilities outside of the district's boundaries.

Chairman Girod Jackson III is in the chair.

Representative Danahay offered a motion to involuntarily defer House Bill No. 1119, to which there were no objections. The motion passed by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Senate Bill No. 617 by Senator Donahue

At the request of the author, Representative Pugh presented Senate Bill No. 617, which changes the composition of the board of commissioners of the St. Tammany Parish Development District.

Ms. Reneé Roberts, representing the St. Tammany Parish Government, P.O. Box 628, Covington, LA 70434, (985) 898-2700; and Mr. Dino Paternostro, representing the Northshore Legislative Alliance, 118 West Hall, Slidell, LA 70460, were present in support of the bill.

Representative Wesley Bishop offered a motion to report Senate Bill No. 617 favorably. There were no objections. The motion was carried by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Representative Pugh offered a motion to place Senate Bill No. 617 on the Local & Consent calendar. Without objection, the motion passed by a vote of 12 yeas, 0 nays, and 1 abstention with Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Pugh, and Willmott voting yea. Chairman Girod Jackson III abstained.

Senate Bill No. 315 by Senator Amedee

On behalf of Senator Amedee, Representative Berthelot presented Senate Bill No. 315, which re-creates the Department of Culture, Recreation and Tourism.

Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Representative Girod Jackson III offered a motion to place Senate Bill No. 315 on the Local & Consent Calendar. There was no objection to the motion, which passed by a vote of 14 yeas and 0 nays. Senate Bill No. 622 by Senator Amedee

At the request of the author, Representative Berthelot presented Senate Bill No. 622, which authorizes the lieutenant governor to perform the duties, functions, and responsibilities of the secretary of culture, recreation and tourism.

Representative Honoré offered a motion to report Senate Bill No. 622 favorably. There was no objection, and the motion passed by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Representative Girod Jackson III offered a motion to place Senate Bill No. 622 on the Local & Consent Calendar. There was no objection to the motion, which passed by a vote of 14 yeas and 0 nays. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Girod Jackson III, Norton, Pugh, and Willmott voted yea.

Senate Bill No. 361 by Senator Morrell

On behalf of the author, Representative Brossett presented Senate Bill No. 361, which provides relative to 9-1-1 fees for the Orleans Communications District.

Representative Girod Jackson III proposed an amendment that changes the type of service to which certain proposed additional service charges apply from broadband service to voice over internet protocol service. Without objection, the amendment was adopted by a vote of 14 yeas and

0 nays. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Girod Jackson III, Norton, Pugh, and Willmott voted yea.

Mr. George Sutton, representing AT&T, 731 Lakeland Drive, Baton Rouge, LA 70802, (225) 205-6160, provided information on the legislation.

Senate Bill No. 80 by Senator Cortez

Senate Bill No. 312 by Senator Cortez

Senate Bill No. 312 provides that the position of assistant police chief, relative to the towns of Broussard, Carencro, Scott, and Youngsville, shall be in the unclassified service. The author presented resolutions from the mayor and/or city councils of Broussard, Carencro, Kaplan, Scott, and Youngsville (Exhibit A) in favor of the legislation.

Senate Bill No. 496 by Senator Perry

At the request of the author, Representative Hensgens presented Senate Bill No. 496, which provides relative to the authority of the chief of police for the city of Kaplan and the position of assistant to the chief of police.

Representatives Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yeas. Chairman Girod Jackson III abstained.

Representative Honore offered a motion to place Senate Bill No. 496 on the Local & Consent Calendar, to which there was no objection. The motion passed by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yeas. Chairman Girod Jackson III abstained.

House Bill No. 335 by Representative Lorusso

The author presented House Bill No. 335 which, relative to the New Orleans City Park Taxing District, provides with respect to procedures relative to use of state sales tax increments for tax increment financing.

Representative Pugh proposed an amendment that, relative to the submission of a local economic development project to the Joint Legislative Committee on the Budget for approval, requires that the commissioner of administration submit the project rather than the district and requires that the submittal include a written evaluation and determination by the division of administration. There were no objections to the amendment, which was adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yeas. Chairman Girod Jackson III abstained.

Representative Berthelot offered a motion to report House Bill No. 335 with amendments. Without objection, the motion was carried by a vote of 9 yeas, 0 nays, and 1 abstention with Representatives Barras, Barrow, Berthelot, Brossett, Danahay, Havard, Honoré, Pugh, and Willmott voting yeas. Chairman Girod Jackson III abstained.

House Bill No. 1103 by Representative Leger

House Bill No. 1103, which provides relative to the Louisiana Sports and Entertainment District, was presented by Speaker Pro Tempore Leger.

Representative Girod Jackson III proposed amendments that clarify that Louisiana sales tax increments, rather than sales taxes, may be dedicated to the district; prohibit state sales tax increments from exceeding the aggregate portion of the local sales tax increments dedicated for district purposes; and, relative to the submittal of the local economic development project to the

Joint Legislative Committee on the Budget for approval, require that the submittal include a written evaluation and determination by the division of administration and make provisions relative to the contents of the submittal. There were no objections to the amendments, which were adopted by a vote of 11 yeas and 0 nays. Representatives Badon, Barras, Barrow, Berthelot, Brossett, Danahay, Havard, Honoré, Girod Jackson III, Pugh, and Willmott voted yea.

Representative Brossett offered a motion to report House Bill No. 1103 with amendments. Without objection, the motion was carried by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Brossett, Danahay, Havard, Honoré, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

House Bill No. 681 by Representative Leger

The author presented House Bill No. 681, which provides relative to energy efficiency or renewable energy improvement loans.

Representative Girod Jackson III offered amendments that provide relative to a property owner's options for acquiring energy efficiency or renewable energy improvements and requirements for entering into a financing agreement for such improvements. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays with Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Danahay, Havard, Honoré, Girod Jackson III, Norton, Ortego, Pugh, and Willmott voting yea.

Speaking in opposition to the legislation was Mr. Joe Gendron, representing the Louisiana Bankers Association, 5555 Bankers Avenue, Baton Rouge, LA 70808, (225) 214-4837; and Mr. David Boneno, representing the Louisiana Bankers Association, 5555 Bankers Avenue, Baton Rouge, LA 70808, (225) 387-3282.

Representative Wesley Bishop offered a motion to report House Bill No. 681 with amendments, to which Representative Barras objected. The secretary called the roll. The motion failed by a vote of 2 yeas, 10 nays, and 1 abstention. Representatives Badon and Wesley Bishop voted yea. Representatives Barras, Barrow, Berthelot, Danahay, Havard, Honoré, Norton, Ortego, Pugh, and Willmott voted nay. Chairman Girod Jackson III abstained.

Senate Bill No. 630 by Senator Morrell

The author presented Senate Bill No. 630, which authorizes a fixed rate for emergency telephone service charges in St. Bernard Parish.

Representative Pugh offered a motion to report Senate Bill No. 630 favorably. There were no objections. The motion passed by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives

Badon, Barras, Barrow, Berthelot, Wesley Bishop, Danahay, Havard, Honoré, Norton, Ortego, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Representative Pugh offered a motion to place Senate Bill No. 630 on the Local & Consent Calendar and without objection, the motion was carried by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Danahay, Havard, Honoré, Norton, Ortego, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Senate Bill No. 98 by Senator Morrell

Senate Bill No. 98 provides for the expenditure of public funds by any fire protection district, municipal fire department, or volunteer fire department.

Representative Berthelot proposed an amendment that changes meals covered by proposed law from meals for firefighters performing emergency services to a meal in conjunction with an event honoring the firefighter. There was no objection to the amendment, which passed by a vote of 14 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.

Representative Wesley Bishop offered a motion to report Senate Bill No 98 with amendments. Without objection the motion was carried by a vote of 14 yeas, 0 nays, and 1 abstention. Representatives Badon, Barras, Barrow, Berthelot, Wesley Bishop, Brossett, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Pugh, and Willmott voted yea. Chairman Girod Jackson III abstained.
