III. DISCUSSION OF LEGISLATION

Representative Robideaux announced that action on House Bill No. 1082 was voluntarily deferred.

House Bill No. 648 by Representative Patrick Williams

Representative Patrick Williams presented House Bill No. 648, which was amended by the committee on Tuesday, April 17, 2012, with the adoption of a substitute bill to exempt prescription drugs and pharmacists services from local sales and use taxes, beginning January 1, 2014.

Representative Barrow offered a set of amendments to phase-in the mandatory exemption. She also offered a motion to adopt the amendments, to which Representative Wesley Bishop objected. The secretary called the roll and the amendments were adopted by a vote of 14 yeas and 3 nays. Those voting yea were Representatives Barras, Barrow, Broadwater, Burford, Guillory, Hoffmann, Johnson, Lorusso, Ritchie, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott. Representatives Adams, Wesley Bishop, and Danahay voted nay.

There was no further discussion on the bill.

Representative Patrick Williams offered a motion to report House Bill No. 648 by substitute, to which Representative Ritchie objected. House Bill No. 648 was reported by substitute by a vote of 16 yeas and 1 nay. Those voting yea were Representatives Adams, Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hoffmann, Johnson, Lorusso, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott. Representative Ritchie voted nay.

House Bill No. 1106 by Representative Katrina Jackson

Representative Katrina Jackson presented House Bill No. 1106, which would authorize a rebate for donations to certain public schools.

Representative Robideaux offered a set of amendments to add eligibility of donations to public schools which received a letter grade of "B" for the rebate and authorize the rebate amount for such donations to be equal to 25% of the donation; add purposes for which donations will be used by the public school; and add a requirement for the receipt issued by the public school to include certification by the school that donations will be used for one of the authorized purposes set forth in proposed law. He also offered a motion to adopt the amendments, to which there was no objection. The amendments were adopted by a vote of 13 yeas and 0 nays. Those voting yea were Representatives Adams, Wesley Bishop, Broadwater, Burford, Guillory, Hoffmann, Johnson, Lorusso, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

There was no further discussion on the bill.

Representative Wesley Bishop offered a motion to report House Bill No. 1106 with amendments, to which there was no objection. House Bill No. 1106 was reported with amendments by a vote of 16 yeas and 0 nays. Those voting yea were Representatives Adams, Barras, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hoffmann, Johnson, Lorusso, Ritchie, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

House Bill No. 1076 by Representative Seabaugh

On behalf of Representative Seabaugh, Representative Thompson presented House Bill No. 1076, which would require that charges imposed by contractors retained for the collection of taxes due to the Department of Revenue (DOR) be deducted from the total amount of money collected from a tax debtor.

There was no further discussion on the bill.

Representative Robideaux offered a motion to involuntarily defer action on House Bill No. 1076, to which there was no objection. Action on House Bill No. 1076 was involuntarily deferred by a vote of 16 yeas and 0 nays. Those voting yea were Representatives Barras, Barrow, Wesley Bishop, Burford, Danahay, Guillory, Hoffmann, Johnson, Lambert, Lorusso, Ritchie, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

Senate Bill No. 60 by Senator Riser

On behalf of Senator Riser, Representative Robideaux presented Senate Bill No. 60, which would provide relative to the payment of certain insurance premium cost for certain retired assessors and assessors' employees in Caldwell and Lincoln parishes.

There was no further discussion on the bill.

Representative Robideaux offered a motion to report Senate Bill No. 60 favorably, to which there was no objection. Senate Bill No. 60 was reported favorably by a vote of 17 yeas and 0 nays. Those voting yea were Representatives Barras, Barrow, Wesley Bishop, Broadwater, Burford, Danahay, Guillory, Hoffmann, Johnson, Lambert, Lorusso, Ritchie, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

House Bill No. 1120 by Representative Lambert

Representative Lambert presented House Bill No. 1120, which would exempt resales of services from local sales tax.

Representative Lambert offered a set of amendments to delete the provision of proposed law to change the required level of compliance with rules and regulations necessary to determine whether or not a sale was a sale for resale and add discretion for a tax collector to require a taxpayer to provide a local tax exemption certificate in certain instances. He offered a motion to adopt the amendments, to which there was no objection. The amendments were adopted by a vote of 15 yeas and 0 nays. Those voting yea were Representatives Barras, Barrow, Wesley Bishop, Burford, Danahay, Guillory, Johnson, Lambert, Lorusso, Ritchie, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.

There was no further discussion on the bill.

Representative Wesley Bishop offered a motion to report House Bill No. 1120 with amendments, to which there was no objection. House Bill No. 1120 was reported with amendments by a vote of 15 yeas and 0 nays. Those voting yea were Representatives Barras, Barrow, Wesley Bishop, Burford, Danahay, Guillory, Johnson, Lambert, Lorusso, Ritchie, Robideaux, Thibaut, Whitney, Patrick Williams, and Willmott.
