### III. DISCUSSION OF LEGISLATION

#### **House Bill No. 531 by Representative Havard**

Representative Havard authored House Bill No. 531, a constitutional amendment which provides relative to increasing the financial burden of public school systems.

There was no discussion on the bill.

Representative Burns offered a motion to voluntarily defer action on House Bill No. 531. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Barras, Berthelot, Brossett, Danahay, Gaines, Miller, Pugh, Schroder, and Burns voted yea.

#### **House Bill No. 387 by Representative Schroder**

Representative Schroder presented House Bill No. 387, which protects public employees from reprisal for providing information to a legislator or legislative committee upon request.

Representative Schroder offered a set of amendments to define "request of a legislator or legislative committee" and to subject actions or remedy directed at certain classified employees to approval from the appropriate civil service commission prior to implementation.

Representative Schroder offered a motion to adopt the amendments. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Barras, Berthelot, Brossett, Danahay, Gaines, Miller, Pugh, Schroder, and Burns voted yea.
