III. DISCUSSION OF LEGISLATION

Senate Bill No. 206 by Senator John Smith

At the request of Senator John Smith, Representative Dorothy Sue Hill presented Senate Bill No. 206, which designates the mayhaw fruit tree as the official state fruit tree.

Representative Pugh offered a motion to report Senate Bill No. 206 favorably. Without objection, Senate Bill No. 206 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Billiot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

House Bill No. 489 by Representative Wesley Bishop

Chairman Badon announced that House Bill No. 489, a constitutional amendment that authorizes the donation of certain blighted or abandoned housing property to the residents of the Lower Ninth Ward of the city of New Orleans, had been voluntarily deferred by the author.

House Bill No. 1001 by Representative Wesley Bishop

Chairman Badon announced that House Bill No. 1001, which authorizes the city of New Orleans to sell blighted property in the Lower Ninth Ward for a fixed price, had been voluntarily deferred by the author.

House Bill No. 1144 by Representative Jared Brossett

Chairman Badon announced that House Bill No. 1144, which provides relative to fees charged by the Louisiana Housing Corporation, had been voluntarily deferred by the author.

Senate Bill No. 387 by Senator LaFleur

Chairman Badon announced that Senate Bill No. 387, which provides relative to local governing authorities and special districts, had been voluntarily deferred by the author.

Senate Bill No. 590 by Senator Morrell

At the request of Senator Morrell, Representative Jared Brossett presented Senate Bill No. 590, which provides relative to the Oak Island Neighborhood Improvement District.

Representative Wesley Bishop offered a motion to report Senate Bill No. 590 favorably. Without objection, Senate Bill No. 590 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Billiot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Senate Bill No. 572 by Senator Murray

On behalf of Senator Murray, Rep. Brossett presented Senate Bill No. 572, which provides relative to the Lakeview Crime Prevention District.

Representative Brown offered a motion to report Senate Bill No. 572 favorably. Without objection, Senate Bill No. 572 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Billiot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Senate Bill No. 97 by Senator Nevers

Senator Nevers presented Senate Bill No. 97, which repeals provisions relative to the Tangipahoa Parish Economic Development District.

Representative Brown offered a motion to report Senate Bill No. 97 favorably. Without objection, Senate Bill No. 97 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Billiot, Wesley Bishop, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Senate Bill No. 262 by Senator Nevers

Senator Nevers presented Senate Bill No. 262, which provides for a per diem for board members of the Washington Parish Gas Utility District No. 2.

Representative Norton offered a motion to report Senate Bill No. 262 favorably. Without objection, Senate Bill No. 262 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Badon, Billiot, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Senate Bill No. 624 by Senator Kostelka

Senator Kostelka presented Senate Bill No. 624, which authorizes by population certain municipalities to levy a sales tax not to exceed one percent.

Representative Badon offered a set of amendments that changed the maximum population of municipalities to which the bill is applicable from 13,250 to 13,075. Representative Badon offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Badon, Billiot, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yea.

Representative Billiot offered a motion to report Senate Bill No. 624 with amendments. Without objection, Senate Bill No. 624 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Badon, Billiot, Brossett, Brown, Danahay, Havard, Honoré, Norton, Pugh, and Willmott voted yea.

Senate Bill No. 152 by Senator John Smith

On behalf of Senator John Smith, Representative Billiot presented Senate Bill No. 152, which provides for increasing the board membership to ten on the War Memorial Civic Center Board in the town of DeRidder.

Representative Billiot offered a motion to report Senate Bill No. 152 favorably. Without objection, Senate Bill No. 152 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Badon, Billiot, Brossett, Brown, Danahay, Havard, Norton, Pugh, and Willmott voted yea.

House Bill No. 1164 by Representative Jackson

Chairman Badon announced that House Bill No. 1164, which provides relative to fiscal administrators, including provisions for their powers and duties and prohibition of retroactive application of certain provisions of law relative to fiscal administrators, had been voluntarily deferred by the author.

Dr. Maurice Millere, representing Jonesboro Homer Civil Rights Advocacy Association (no address given), 202) 735-7656, was present in support of the bill.

Senate Bill No. 442 by Senator Martiny

At the request of Senator Martiny, Representative Bryan Adams presented Senate Bill No. 442, which provides relative to investments by political subdivisions.

Senate Bill No. 630 by Senator Martiny

Senator Martiny presented Senate Bill No. 630, which provides for the qualification of a newspaper to publish official proceedings, legal notices, or advertisements in Orleans Parish or Jefferson Parish.

House Bill No. 1083 by Representative Badon

Representative Badon presented House Bill No. 1083, which authorizes the governing authority of the city of New Orleans to levy an additional hotel occupancy tax.

Mayor Mitch Landrieu, representing the city of New Orleans, 1300 Perdido Street, New Orleans, LA 70112, spoke in support of the bill and presented a reprint of an article from *The New Orleans Advocate* dated April 23, 2014, entitled "Guest Commentary: Preparing for the Tough Challenges Ahead (Exhibit A).

Representative Brossett offered a motion to report House Bill No. 1083 with amendments (that had been previously adopted at the April 24, 2014, meeting of the House Committee on Municipal, Parochial and Cultural Affairs), to which Representative Willmott objected. The secretary called the roll and House Bill No. 1083 was reported with amendments by a vote of 7 yeas and 6 nays. Representatives Badon, Barrow, Billiot, Wesley Bishop, Brossett, Burrell, and Woodruff voted yea. Representatives Barras, Berthelot, Havard, Norton, Pugh, and Willmott voted nay.

House Bill No. 1210 by Representative Moreno

Representative Moreno presented House Bill No. 1210, which authorizes the parish of Orleans to levy a sales tax on tobacco products sold in the parish.

Representative Badon offered a set of amendments that changed the amount of the proposed tax from \$0.75 to \$0.80 and specified the distribution of the additional \$0.05. Representative Badon offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Badon, Barras, Barrow, Berthelot, Billiot, Burrell, Havard, Honoré, Norton, Pugh, and Willmott voted yea.

Representatives Berthelot, Brown, Havard, Norton, Ortego, Pugh, and Willmott voted nay.

Senate Bill No. 617 by Senator Amedee

At the request of Senator Amedee, Representative Berthelot presented Senate Bill No. 617, which provides relative to the creation of Ascension Parish Road Infrastructure Development Districts.

Representative Berthelot offered a set of amendments that made the levy of a tax or assessment subject to voter approval unless there are no qualified voters in the district, and granted that the authority to levy a tax or assessment is in addition to powers and rights conferred by any other general or special law. Representative Berthelot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Badon, Berthelot, Billiot, Brown, Burrell, Havard, Honoré, Norton, Ortego, Pugh, Willmott, and Woodruff voted yea.

Mr. Saun Sullivan, representing Denham Springs Land Development (no address given), (225) 769-7696, was present to provide information.
