III. DISCUSSION OF LEGISLATION

Senate Bill No. 648 by Senator Dorsey-Colomb

Senator Dorsey-Colomb presented Senate Bill No. 648, which creates and provides for the Old LNB Building Redevelopment District in East Baton Rouge Parish.

Mr. Davis Rhorer, representing Downtown Development, 247 Florida Street, Baton Rouge, LA, (225) 389-5526; Mr. Bud Courson and Mr. Jim Nickel, representing Wampold Companies, 457 Lafayette Street, Baton Rouge, LA; Mr. Mike Wampold, representing Wampold Companies, 4171 Essen Ln #450, Baton Rouge, LA 70809; and Mr. Jordan B. Monsour, representing Wampold Companies and Butler Snow, 445 North Boulevard, Suite 810, Baton Rouge, LA 70802, (225) 325-8703, were present in support of the bill but declined to speak.

Representative Barrow offered a motion to report Senate Bill No. 648 favorably. Without objection, Senate Bill No. 648 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Badon, Barrow, Berthelot, Billiot, Wesley Bishop, Brown, Burrell, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Senate Bill No. 674 by Senator Nevers

At the request of Senator Nevers, Senator Dorsey-Colomb presented Senate Bill No. 674, which provides relative to incorporation of unincorporated areas.

Representative Billiot offered a set of amendments that added Jefferson to the list of parishes exempted from proposed law. Representative Billiot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Badon, Barrow, Berthelot, Billiot, Wesley Bishop, Brown, Burrell, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Representative Berthelot offered a set of amendments that added Livingston to the list of parishes exempted from proposed law. Representative Berthelot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Badon, Barrow, Berthelot, Billiot, Wesley Bishop, Brown, Burrell, Danahay, Havard, Honoré, Norton, Pugh, Willmott, and Woodruff voted yea.

Representative Havard offered a set of amendments that added East Feliciana to the list of parishes exempted from proposed law. Representative Havard offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Badon, Barrow, Berthelot, Billiot, Wesley Bishop, Brown, Burrell, Havard, Honoré, Norton, Ortego, Pugh, Willmott, and Woodruff voted yea.

Mr. Bud Courson and Mr. Jim Nickel, representing Police Jury Association of Louisiana, 453 Lafayette Street, Suite A, Baton Rouge, LA 70802, (225) 346-6900; Ms. Paulette Bailey-Wilson, representing Louisiana Municipal Association, 4919 Jamestown Avenue, Suite 103, Baton Rouge, LA 70808; Mr. George Marretta, representing Louisiana Municipal Association, 700 North 10th Street, Baton Rouge, LA 70802, (225) 344-5001; and Mr. Roland Dartez, representing Police Jury Association of Louisiana, 707 North 7th Street, Baton Rouge, LA 70802, (225) 343-2835, were present in support of the bill but declined to speak.

Representative Wesley Bishop offered a motion to report Senate Bill No. 674 with amendments. Without objection, Senate Bill No. 674 was reported with amendments by a vote of 15 yeas and 0 nays. Representatives Badon, Barrow, Berthelot, Billiot, Wesley Bishop, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Pugh, Willmott, and Woodruff voted yea.

Approval of 2013 Regular Session committee meeting minutes
