III. DISCUSSION OF LEGISLATION

House Bill No. 95 by Representative Richard

Representative Richard presented House Bill No. 95, which creates the Lafourche Arc Taxing District.

a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Burrell, Danahay, Honoré, Norton, Ortego, Pugh, Willmott, and Woodruff voted yea.

Representative Pugh offered a motion to report House Bill No. 95 with amendments. Without objection, House Bill No. 95 was reported with amendments by a vote of 15 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Pugh, Willmott, and Woodruff voted yea.

House Bill No. 216 by Representative Seabaugh

Representative Seabaugh presented House Bill No. 216, which provides relative to the hotel occupancy tax that the Shreveport-Bossier Convention and Tourist Bureau is authorized to levy.

Representative Burrell offered a motion to report House Bill No. 216 favorably. Without objection, House Bill No. 216 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Pugh, and Willmott voted yea.

House Bill No. 144 by Representative Arnold

Representative Arnold presented House Bill No. 144, which provides relative to the powers and duties of the Algiers Development District.

One person completed a witness card in support of House Bill No. 144 but declined to speak.

Representative Ortego offered a motion to report House Bill No. 144 favorably. Without objection, House Bill No. 144 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Ortego, and Willmott voted yea.

House Bill No. 121 by Representative Pope

Representative Pope presented House Bill No. 121, which provides relative to the civil service status of employees of the housing authority of Denham Springs.

One person completed a witness card in support of House Bill No. 121 but declined to speak.

Representative Havard offered a motion to report House Bill No. 121 favorably. Without objection, House Bill No. 121 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 256 by Representative Pope

Representative Pope presented House Bill No. 256, which provides relative to certain interlocal risk management agencies.

House Bill No. 145 by Representative Burford

Representative Burford presented House Bill No. 145, which authorizes DeSoto Parish Fire District No. 3 to collect a service charge on structures.

Representative Brown offered a motion to report House Bill No. 145 favorably. Without objection, House Bill No. 145 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 23 by Representative Hensgens

Representative Hensgens presented House Bill No. 23, which provides with respect to the Vermilion Parish Economic Development District.

Representative Badon offered amendments to add a provision that members of the board in office on the effective date of <u>proposed law</u> shall serve until the expiration of their terms. Representative Badon offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Willmott, and Woodruff voted yea.

Mr. Richard Guilbeau, representing Vermilion Parish Economic Development District, 407 Charity Suite 102, Abbeville, LA 70516, (337) 898-1878, spoke in support of House Bill No. 23.

Representative Brown offered a motion to report House Bill No. 23 with amendments. Without objection, House Bill No. 23 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 200 by Representative Harrison

Representative Harrison presented House Bill No. 200, which provides relative to the Terrebonne Economic Development Authority. Representative Harrison presented letters of support for House Bill No. 200 from Houma-Terrebonne Chamber of Commerce (Exhibit C) and South Central Industrial Association (Exhibit D).

Representative Badon offered amendments to:

- 1. Change the qualifications for the two members appointed by the governing authority of Terrebonne Parish and the member appointed by the president of Terrebonne Parish.
- 2. Remove provisions that grant to the authority the power to use other means to acquire property other than by purchase, donation, grant, exchange, or lease. Additionally remove provisions that grant to the authority the power to use other means to receive money, property, or other assistance other than by grant or donation.

Representative Badon offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Willmott, and Woodruff voted yea.

Mr. Patrick Gordon, representing Terrebonne Parish Government, P.O. Box 2768, Houma, LA, (985) 873-6569, spoke in support of House Bill No. 200.

Mr. Kevin Hayes, representing Louisiana Landowners Association and Adams and Reese, LLP, 450 Laurel Street, Suite 1900, Baton Rouge, LA 70801, (225) 336-5200, provided information.

Representative Havard offered a motion to report House Bill No. 200 with amendments. Without objection, House Bill No. 200 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 8 by Representative Montoucet

Representative Montoucet presented House Bill No. 8, which provides relative to the powers granted to the chief of police for the city of Crowley.

Mr. Fabian Blache, representing Louisiana Association of Chiefs of Police, 700 North 10th Street, Suite 250, Baton Rouge, LA 70802, (225) 387-3261, spoke in support of House Bill No. 8.

One person completed a witness card in support of House Bill No. 8 but declined to speak.

Representative Brown offered a motion to report House Bill No. 8 favorably. Without objection, House Bill No. 8 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Brown, Burrell, Danahay, Havard, Honoré, Ortego, and Willmott voted yea.

House Bill No. 147 by Representative Montoucet

Representative Montoucet presented House Bill No. 147, which authorizes the town of Duson to levy a hotel occupancy tax.

An unnamed representative of three entities completed three witness cards in support of House Bill No. 147 but declined to speak.

Representative Ortego offered a motion to report House Bill No. 147 favorably. Without objection, House Bill No. 147 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, and Willmott voted yea.

House Bill No. 201 by Representative Montoucet

Representative Montoucet presented House Bill No. 201, which provides relative to the board of directors of the Acadia Parish Convention and Visitors Commission.

Representative Ortego offered a motion to report House Bill No. 201 favorably. Without objection, House Bill No. 201 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, and Willmott voted yea.

House Bill No. 124 by Representative Burrell

Representative Burrell presented House Bill No. 124, which provides relative to the boundaries of the Shreveport Downtown Development District.

Representative Ortego offered amendments relative to the expansion of district boundaries that add a requirement that the city council submit any existing ad valorem tax or bonds to the qualified electors of the expanded territory. Representative Ortego offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Willmott, and Woodruff voted yea.

Mr. Jeff Everson, representing the city of Shreveport, 505 Travis, Shreveport, LA 71101, (318) 347-2554, spoke in support of House Bill No. 124.

Representative Ortego offered a motion to report House Bill No. 124 with amendments. Without objection, House Bill No. 124 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 769 by Representative Burrell

Representative Burrell presented House Bill No. 769, which creates the Shreveport Implementation and Redevelopment Authority. Representative Burrell presented Resolution No. 62 of 2015 from the city of Shreveport in support of House Bill No. 769 (Exhibit E).

Representative Norton offered amendments to remove authority for the authority to acquire property by expropriation or any means other than gift, grant, purchase, or lease. Representative Norton offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Willmott, and Woodruff voted yea.

Mr. Jeff Everson, representing the city of Shreveport, 505 Travis, Shreveport, LA 71101, (318) 347-2554, spoke in support of House Bill No. 769.

Six persons completed witness cards in support of House Bill No. 769 but declined to speak.

Representative Norton offered a motion to report House Bill No. 769 with amendments. Without objection, House Bill No. 769 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 463 by Representative Berthelot

Representative Berthelot presented House Bill No. 463, which provides relative to the appointment and term of municipal officials in a Lawrason Act municipality.

One person completed a witness card in support of House Bill No. 463 but declined to speak.

Representative Ortego offered a motion to report House Bill No. 463 favorably. Without objection, House Bill No. 463 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 26 by Representative Miller

Representative Miller presented House Bill No. 26, which provides with respect to powers of the governing authority of St. Charles Parish relative to grass cutting.

House Bill No. 50 by Representative Danahay

Representative Danahay presented House Bill No. 50, which provides a technical correction relative to additional compensation authorized to be paid to certain firefighters.

Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Willmott, and Woodruff voted yea.

House Bill No. 267 by Representative Danahay

Representative Danahay presented House Bill No. 267, which provides relative to the work schedule of certain employees of the Sulphur Police Department.

Two persons completed witness cards in support of House Bill No. 267 but declined to speak.

Representative Brown offered a motion to report House Bill No. 267 favorably. Without objection, House Bill No. 267 was reported favorably by a vote of 14 yeas and 0 nays. Representatives Badon, Barras, Berthelot, Billiot, Bouie, Brown, Burrell, Danahay, Havard, Honoré, Norton, Ortego, Willmott, and Woodruff voted yea.
