III. DISCUSSION OF LEGISLATION

House Bill No. 140 by Representative Howard

Representative Howard presented House Bill No. 140, which adds current and retired attorney generals and designated assistant attorneys general to list of officials who can carry concealed weapons.

Attorney General Jeff Landry, Department of Justice, Livingston Building, Baton Rouge, LA 70804, Landry, J@ag.louisiana.gov, spoke in support of House Bill No. 140.

Representative Howard offered an amendment to add assistant attorneys general to the list of those who can lawfully carry concealed weapons. Representative Howard offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Mack, Adams, Bacala, Carpenter, Dwight, Hodges, Howard, Terry Landry, and Pylant voted yea.

Representative Terry Landry offered a motion to report House Bill No. 140 with amendments. Without objection, House Bill No. 140 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Hodges, Howard, James, Terry Landry, and Pylant voted yea.

House Bill No. 223 by Representative Terry Landry

Representative Terry Landry presented House Bill No. 223, which provides with respect to illegal carrying of weapons.

Representative Terry Landry offered an amendment to exempt the possession of marijuana of 14 grams or less from additional penalties of possession of a firearm while possessing a controlled dangerous substance. Representative Terry Landry offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Hodges, Howard, James, Terry Landry, and Pylant voted yea.

Representative Bacala offered a motion to report House Bill No. 223 with amendments. Without objection, House Bill No. 223 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Hazel, Hodges, Howard, James, Terry Landry, Norton, and Pylant voted yea.

House Bill No. 440 by Representative Jackson

Representative Jackson presented House Bill No. 440, which provides relative to parole for persons convicted of crimes of violence and provides for the creation and administration of the Programs to Reduce Recidivism Fund.

Representative Norton offered a motion to report House Bill No. 440 favorably. Without objection, House Bill No. 440 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Hazel, Hodges, Howard, James, Terry Landry, Norton, and Pylant voted yea.

House Bill No. 802 by Representative Jackson

Representative Jackson presented House Bill No. 802, which creates a procedure for designating certain crimes in the court minutes as a crime of violence and provides relative to the benefits and restrictions based on such designation.

Representative Norton offered amendments to provide that the designation by the court as a crime of violence in the court minutes is only for the purpose of determining whether the defendant is eligible for suspension or deferral of sentence or for participation in a drug division probation program and to remove the provisions of proposed law regarding reentry preparation programs, community resource centers, rehabilitation and workforce development programs, sentencing of habitual offenders, diminution of sentence, parole eligibility, and eligibility to receive technical violations. Therefore, any person convicted of a crime of violence as defined by present law (R.S. 14:2(B)) will be subject to present law provisions for these matters regardless of how the court designates the person's offense in the court minutes pursuant to proposed law. Representative Norton offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Mack, Bacala, Bagneris, Carpenter, Dwight, Hazel, Hodges, Howard, James, Terry Landry, Norton, and Pylant voted yea.

Representative Norton offered a motion to report House Bill No. 802 with amendments. Without objection, House Bill No. 802 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Hazel, Hodges, Howard, James, Terry Landry, Lopinto, Norton, and Pylant voted yea.

House Bill No. 4 by Representative Ivey

Representative Ivey presented House Bill No. 4, a constitutional amendment, which provides that the right to keep and bear arms includes the right to carry a concealed handgun without a permit or license. He provided the committee members copies of a signed petition included in this file as Exhibit "A".

Representative Terry Landry offered a motion to involuntarily defer action on House Bill No. 4. Without objection, action on House Bill No. 4 was involuntarily deferred by a vote of 14 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Gaines, Hazel, Howard, James, Terry Landry, Lopinto, Norton, and Pylant voted yea.

House Bill No. 6 by Representative Ivey

Representative Ivey presented House Bill No. 6, which excludes carrying a concealed handgun from the crime of illegal carrying of weapons for certain persons.

The secretary called the roll, and action on House Bill No. 6 was involuntarily deferred by a vote of 8 yeas and 4 nays. Representatives Adams, Bagneris, Carpenter, Gaines, Hazel, James, Terry Landry, and Norton voted yea. Representatives Bacala, Dwight, Howard, and Pylant voted nay.

House Bill No. 315 by Representative Ivey

Representative Ivey presented House Bill No. 315, which provides with respect to an enhanced concealed handgun permit.

Representative Gaines offered a motion to involuntarily defer action on House Bill No. 315. Without objection, action on House Bill No. 315 was involuntarily deferred by a vote of 12 yeas and 0 nays. Representatives Mack, Bacala, Bagneris, Carpenter, Dwight, Gaines, Hazel, Howard, James, Terry Landry, Norton, and Pylant voted yea.

House Bill No. 317 by Representative Ivey

Representative Ivey presented House Bill No. 317, which increases penalty provisions for certain crimes when a firearm is possessed, discharged, or used.

Representative James offered a motion to involuntarily defer action on House Bill No. 317, to which Representative Bacala objected and offered a substitute motion to report House Bill No. 317 favorably, to which Representative James objected. The secretary called the roll, and by a vote of 5 yeas and 8 nays, the motion failed to pass. Representatives Adams, Bacala, Dwight, Howard, and Pylant voted yea. Representatives Bagneris, Carpenter, Gaines, Hazel, James, Terry Landry, Lopinto, and Norton voted nay.

The original motion offered by Representative James to involuntarily defer action on House Bill No. 317 was considered, to which Representative Pylant objected. The secretary called the roll, and action on House Bill No. 317 was involuntarily deferred by a vote of 8 yeas and 5 nays. Representatives Bagneris, Carpenter, Gaines, Hazel, James, Terry Landry, Lopinto, and Norton voted yea. Representatives Adams, Bacala, Dwight, Howard, and Pylant voted nay.

Witness cards submitted by individuals who did not speak are as follows: 3 in support and 2 in opposition. Witness cards are included in the committee records.

House Bill No. 318 by Representative Ivey

Representative Ivey presented House Bill No. 318, which creates the crime of failure to identify the possession of a concealed handgun to a law enforcement officer.

On behalf of the author, Representative Mack offered an amendment to provide penalties for failure to notify a law enforcement officer if a concealed weapon is on his person. Representative Mack

offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 14 yeas and 0 nays. Representatives Mack, Adams, Bacala, Bagneris, Carpenter, Dwight, Gaines, Hazel, Howard, James, Terry Landry, Lopinto, Norton, and Pylant voted yea.

Without objection, action on House Bill No. 318 was voluntarily deferred by a vote of 12 yeas and 0 nays. Representatives Mack, Bacala, Bagneris, Carpenter, Dwight, Gaines, Hazel, Howard, James, Terry Landry, Norton, and Pylant voted yea.

House Bill No. 319 by Representative Ivey

Representative Ivey presented House Bill No. 319, which provides a definition of a "concealed" weapon.

On behalf of the author, Representative Mack offered a motion to voluntarily defer action on House Bill No. 319. Without objection, action on House Bill No. 319 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Mack, Bacala, Bagneris, Carpenter, Dwight, Gaines, Hazel, Howard, James, Terry Landry, Lopinto, Norton, and Pylant voted yea.

House Bill No. 320 by Representative Ivey

Representative Ivey presented House Bill No. 320, which increases penalties for possession of a firearm during the commission of a crime of violence.

Representative Pylant offered a motion to report House Bill No. 320 favorably. Without objection, House Bill No. 320 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Mack, Bacala, Bagneris, Carpenter, Dwight, Gaines, Hazel, Howard, James, Terry Landry, Norton, and Pylant voted yea.

Witness cards submitted by individuals who did not speak are as follows: 3 in support and 2 in opposition. Witness cards are included in the committee records.
