III. DISCUSSION OF LEGISLATION

IV. OTHER BUSINESS

Mr. Jay Dardenne, Commissioner of Administration, 1201 North Third Street, Baton Rouge, LA 70802, (225) 342-7000, gave the committee an overview of state agency contracts and discussed the newly implemented LaGOV system. (See Exhibit A)

Commissioner Dardenne discussed, with Representative Richard, the GRAD Act, the process to terminate a contract, and Act 87 from the 2015 Regular Session.

Commissioner Dardenne and Mr. Randy Davis, Assistant Commissioner of Administration, 1201 North Third Street, Baton Rouge, LA 70802, (225) 342-7000, discussed, with Representative Schroder and Representative Hensgens, an approach to reduce state contracts and the distinction between federal funds and the state general fund.

Mr. Davis discussed, with Representative Schroder and Representative Carter, features of the LaGOV system that provides information regarding state contracts.

Commissioner Dardenne discussed, with Representative Henry, budget autonomy for certain state agencies.

Mr. Davis discussed, with Representative Zeringue, how to determine which contracts are reported in the LaGOV system and which ones are not.

Commissioner Dardenne and Mr. Davis discussed, with Representative Bacala, the amount of savings realized, to date, from terminating and/or modifying certain state contracts.

Commissioner Dardenne discussed, with Representative Pylant, inmate housing in Allen and Winn Parish prisons and the per diem paid to sheriffs.
