#### III. DISCUSSION OF LEGISLATION

# **House Bill No. 132 by Representative Hall**

Representative Hall presented House Bill No. 132, which provides relative to the expropriation of property for certain sewer projects in the City of Pineville.

Thomas C. David, Jr., City of Pineville, P.O. Box 89, Alexandria, LA, 71309, (318) 473-2100, spoke in support of House Bill No. 132.

Representative Garofalo offered an amendment to change the effective date. Representative Garofalo offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

Kevin Hayes, Louisiana Landowners Association, 412 North 4<sup>th</sup> Street, Baton Rouge, LA, 70802, (225) 268-2725, spoke in opposition to House Bill No. 132.

Representative Jenkins offered a motion to report House Bill No. 132 with amendments, to which Representative Seabaugh objected. The secretary called the roll, and by a vote of 4 yeas, 5 nays, and 1 abstention, the motion failed to pass. Representatives Robby Carter, Cromer, Gaines, and Jenkins voted yea. Representatives Emerson, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted nay. Representative Garofalo abstained.

Representative Garofalo offered a motion to voluntarily defer action on House Bill No. 132. Without objection, action on House Bill No. 132 was voluntarily deferred by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

## House Bill No. 398 by Representative Moreno

Representative Moreno presented House Bill No. 398, which provides relative to the application of certain limitations on the admissibility of character evidence in civil cases.

Representative Garofalo offered an amendment to delete the phrase "for damages" in order to make proposed law applicable to all civil actions. Representative Garofalo offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

Representative Magee offered a motion to report House Bill No. 398 with amendments. Without objection, House Bill No. 398 was reported with amendments by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

# House Bill No. 556 by Representative Moreno

Representative Moreno presented House Bill No. 556, which provides a three-year liberative prescriptive period for actions arising from cases of rape.

Representative Cromer offered a motion to report House Bill No. 556 favorably. Without objection, House Bill No. 556 was reported favorably by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

# House Bill No. 154 by Representative Montoucet

On behalf of the author, Representative Garofalo offered a motion to voluntarily defer action on House Bill No. 154, a constitutional amendment, which limits the power of the Public Service Commission to regulate nonprofit water utility cooperatives wholly owned by water users. Without objection, action on House Bill No. 154 was voluntarily deferred by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

# **House Bill No. 709 by Representative Hunter**

Representative Hunter presented House Bill No. 709, which authorizes the insurance commissioner to appoint employees of the Department of Insurance as ex officio notaries.

Representative Gregory Miller offered a motion to report House Bill No. 709 favorably. Without objection, House Bill No. 709 was reported favorably by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

# **House Bill No. 193 by Representative Hunter**

Representative Hunter presented House Bill No. 193, which provides with respect to legislative continuance in civil cases.

Representative Seabaugh offered a motion to report House Bill No. 193 favorably. Without objection, House Bill No. 193 was reported favorably by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

# **House Bill No. 186 by Representative Hunter**

Representative Hunter presented House Bill No. 186, a constitutional amendment, which eliminates the involuntary servitude prohibition from the state constitution.

Representative Garofalo offered a motion to voluntarily defer action on House Bill No. 186. Without objection, action on House Bill No. 186 was voluntarily deferred by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

### **House Bill No. 537 by Representative Garofalo**

Representative Garofalo offered an amendment to delete adjustments of fees and maximum charges based on the consumer price index. Representative Garofalo offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1

abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

Representative Garofalo offered an amendment to delete provisions authorizing the payment for handling charges. Representative Garofalo offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, and Seabaugh voted yea. Representative Garofalo abstained.

# House Bill No. 597 by Representative Mike Johnson

Representative Mike Johnson presented House Bill No. 597, which provides for the Pastor Protection Act.

Representative Mike Johnson offered an amendment to remove the language "in connection with" such that the bill applies to organizations that are "supervised or controlled by" religious organizations but not to organizations that are "in connection with" religious organizations. Representative Mike Johnson offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Robby Carter, Cromer, Emerson, Gaines, Jenkins, Mike Johnson, Magee, Gregory Miller, Schexnayder, and Seabaugh voted yea. Representative Garofalo abstained.

Representative Garofalo abstained.
