III. DISCUSSION OF LEGISLATION

Senate Bill No. 275 by Senator Mizell

Senator Mizell presented Senate Bill No. 275, which requires cursive writing be taught in public schools.

Representative Smith offered amendments to Senate Bill No. 275 that would apply proposed law to charter schools. Representative Smith offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Broadwater, Steve Carter, Emerson, Falconer, Hall, Leger, Price, Simon, and Smith voted yea.

Representative Simon offered a motion to report Senate Bill No. 275 with amendments. Without objection, Senate Bill No. 275 was reported with amendments by a vote of 12 yeas and 0 nays.
