III. DISCUSSION OF LEGISLATION

Senate Bill No. 475 by Senator White

Senator White presented Senate Bill No. 475, which creates the Ambulance Transfer Alternatives Task Force.

Representative Pope offered a motion to report Senate Bill No. 475 favorably. Without objection, Senate Bill No. 475 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Pope, Stokes, Horton, Cox, Hensgens, Jackson, Mike Johnson, LeBas, Magee, Dustin Miller, Willmott, and Hoffmann voted yea.

Senator Johns presented Senate Bill No. 397, which provides relative to the Specialized Provider Licensing Act.

Senate Bill No. 473 by Senator Johns

On behalf of Senator Johns, Greg Waddell, Louisiana Hospital Association, 9521 Brookline Ave, Baton Rouge, LA, 70890, (225) 938-0026, presented Senate Bill No. 473, which provides for the Louisiana Health Insurance Premium Payment Program.

Representative Hoffmann offered amendments, which:

1. Revise proposed law relative to identification by DHH of persons who have access to employer-sponsored health coverage to provide that the department shall inquire with each Medicaid applicant at the time of his application and with each Medicaid enrollee at the time of his annual eligibility redetermination whether he has an opportunity to access such employer-sponsored coverage either directly or through a family member.

- 2. Revise proposed law relative to transition of persons into employer-sponsored health coverage to provide that DHH shall develop and execute a plan to transition Medicaid recipients identified as having access to employer-sponsored health insurance coverage into such coverage as soon as is practicable.
- 3. Provide that DHH may consider any other relevant factors in its determination of which Medicaid recipients may participate in the La. Health Insurance Premium Payment Program.
- 4. Make technical, corrective, and clarifying changes.

Representative Hoffmann offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Pope, Stokes, Horton, Cox, Hensgens, Jackson, Robert Johnson, LeBas, Magee, Dustin Miller, Willmott, and Hoffmann voted yea.

Representative Dustin Miller offered concept amendments, which inserts the following language on page 2, line 12:

1. The department may include any other relevant factors in their determination of which enrollees may participate in the program.

Representative Dustin Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Pope, Stokes, Horton, Cox, Hensgens, Jackson, Mike Johnson, Robert Johnson, LeBas, Magee, Dustin Miller, Willmott, and Hoffmann voted yea.
