III. DISCUSSION OF LEGISLATION

House Bill No. 373 by Representative Broadwater

Representative Broadwater presented House Bill No. 373, which provides relative to the Incumbent Worker Training Program.

Representative Broadwater offered a motion to voluntarily defer action on House Bill No. 373. Without objection, action on House Bill No. 373 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Jefferson, Broadwater, Bagley, Cox, Cromer, Falconer, Horton, Hunter, James, McFarland, Miguez, Price, and Simon voted yea.

Senate Bill No. 72 by Senator Peacock

Senator Peacock presented Senate Bill No. 72, which authorizes private employers to provide employment preferences for veterans.

Representative Broadwater offered a technical amendment to Senate Bill No. 3. Representative Broadwater offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Jefferson, Broadwater, Bagley, Cox, Cromer, Falconer, Horton, Hunter, James, McFarland, Miguez, Price, and Simon voted yea.

Senator Peacock presented and provided a handout, Exhibit A, which is included in the committee records.
