III. DISCUSSION OF LEGISLATION

House Bill No. 23 by Representative Reynolds

Representative Reynolds presented House Bill No. 23, which requires the Municipal Employees' Retirement System to establish rules and regulations governing certain procedures relative to the election of trustees to the system board.

House Bill No. 22 by Representative Montoucet

Representative Montoucet presented House Bill No. 22, which establishes a funding deposit account for the Firefighters' Retirement System and authorizes the board of trustees of the system to modify required employer contribution rates in certain circumstances and within certain limits in order to fund the account.

Representative Ivey offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Pearson, Montoucet, Abraham, Bacala, Carpenter, Hollis, Ivey, Jones, and Gregory Miller voted yea.

Representative Ivey offered a motion to report House Bill No. 22 with amendments. Without objection, House Bill No. 22 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Pearson, Montoucet, Abraham, Bacala, Carpenter, Hollis, Ivey, Jones, and Gregory Miller voted yea.

House Bill No. 24 by Representative Montoucet

Representative Montoucet presented House Bill No. 24, which provides that a member of the Firefighters' Retirement System is not eligible for disability retirement benefits if his disability is indirectly a result of a preexisting condition.

Representative Bacala offered a motion to report House Bill No. 24 favorably. Without objection, House Bill No. 24 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Pearson, Montoucet, Abraham, Bacala, Carpenter, Hollis, Ivey, Jones, and Gregory Miller voted yea.

Representatives Pearson, Montoucet, Abraham, Bacala, Carpenter, Hollis, Ivey, Jones, and Gregory Miller voted yea.

Representative Montoucet offered a motion to report House Bill No. 25 with amendments. Without objection, House Bill No. 25 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Pearson, Montoucet, Abraham, Bacala, Carpenter, Hollis, Ivey, Jones, and Gregory Miller voted yea.

House Bill No. 26 by Representative Montoucet

Representative Montoucet presented House Bill No. 26, which provides relative to appeals of certain disability eligibility decisions in the Firefighters' Retirement System.

Representative Pearson offered amendments to make technical changes. Representative Pearson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Pearson, Montoucet, Abraham, Bacala, Carpenter, Hollis, Ivey, Jones, and Gregory Miller voted yea.
