III. DISCUSSION OF LEGISLATION

House Concurrent Resolution No. 2 by Representative Bishop

Representative Marcelle offered a motion to report House Bill No. 356 with amendments, to which Representative Pope objected. The secretary called the roll, and House Bill No. 356 was reported with amendments by a vote of 12 yeas, 1 nay, and 2 abstentions. Representatives Terry Brown, Carpenter, Franklin, Gisclair, Guinn, Hall, Hill, LeBas, Marcelle, Norton, Pierre, and White voted yea. Representative Pope voted nay. Representatives Havard and Terry Landry abstained.

House Bill No. 357 by Representative Leger

Representative Leger presented House Bill No. 357, which provides relative to funds to be utilized for state rail freight service assistance.

Representatives Havard, Terry Brown, Carpenter, Gisclair, Hall, Hill, Howard, Terry Landry, LeBas, Marcelle, Norton, Pierre, and White voted yea.
