III. DISCUSSION OF LEGISLATION

Senate Bill No. 71 by Senator Donahue

Senator Donahue presented Senate Bill No. 71, which provides relative to TOPS award amounts.

Representative Leger offered a motion to involuntarily defer action on House Bill No. 239. Without objection, action on House Bill No. 239 was involuntarily deferred by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Broadwater, Steve Carter, Emerson, Falconer, Hall, Hilferty, Leger, Simon, and Smith voted yea.

House Bill No. 113 by Representative Broadwater

Representative Broadwater presented House Bill No. 113, which removes termination of the authority of public postsecondary education management boards to establish and increase student fees.

Representative Broadwater offered amendments to House Bill No. 113 which, instead of granting the fee authority to the management boards without limitation, limit this authority to the 2017-2018, 2018-2019, and 2019-2020 academic years. Representative Broadwater offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Broadwater, Steve Carter, Falconer, Hall, Hilferty, Leger, Price, Simon, and Smith voted yea.

Representative Gary Carter presented House Bill No. 390, which provides relative to Tuition Opportunity Program for Students (TOPS) award amounts and for procedures for reducing award amounts in the event of insufficient funding.

Representative Nancy Landry offered amendments to House Bill No. 390 that would: eliminate coupling tuition with TOPS to indicate who will receive a cut and who will not; apply only to sophomores; and, if TOPS is not fully funded, allow students who made higher than a 30 on the ACT and whose family income is less than \$60,000 to be exempt from cuts to their awards. Representative Nancy Landry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Broadwater, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Leger, Price, Simon, and Thomas voted yea.

The secretary called the roll, and the motion failed to pass by a vote of 6 yeas, 7 nays, and 1 abstention. Representatives Bouie, Broadwater, Hall, Leger, Price, and Smith voted yea. Representatives Amedee, Steve Carter, Edmonds, Emerson, Falconer, Hilferty, and Simon voted nay. Representative Nancy Landry abstained.

Representative Simon offered a motion to involuntarily defer action on House Bill No. 390, to which Representative Price objected. The secretary called the roll, and the motion failed to pass by a vote of 4 yeas, 9 nays, and 1 abstention. Representatives Amedee, Emerson, Falconer, and Simon voted yea. Representatives Bouie, Broadwater, Steve Carter, Edmonds, Hall, Hilferty, Leger, Price, and Smith voted nay. Representative Nancy Landry abstained.

Representative Nancy Landry offered a motion to voluntarily defer action on House Bill No. 390. Without objection, action on House Bill No. 390 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Broadwater, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Leger, Price, Simon, and Smith voted yea.

House Bill No. 242 by Representative Emerson

Representative Emerson presented House Bill No. 242, which requires the State Board of Elementary and Secondary Education (BESE) and local public school boards to post certain information on their respective websites relative to independent evaluations of charter proposals.

Representative Emerson offered amendments to House Bill No. 242 that require BESE and local school boards to send the third-party evaluations and recommendations to the charter applicant by electronic means or hand delivery instead of posting such information on their respective websites. Representative Emerson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Nancy Landry, Amedee, Bouie, Broadwater, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Leger, Price, Simon, and Smith voted yea.

Representative Edmonds offered a motion to report House Bill No. 242 with amendments. Without objection, House Bill No. 242 was reported with amendments by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Broadwater, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Price, Simon, and Smith voted yea.

Representative Foil presented House Bill No. 117, which raises the minimum grade point average required for initial eligibility for a Taylor Opportunity Program for Students (TOPS) Opportunity Award.

Representative Steve Carter offered amendments to House Bill No. 117 to change the proposed law minimum grade point average required for initial eligibility for a TOPS Opportunity Award from 3.00 to 2.75. Representative Steve Carter offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Nancy Landry, Amedee, Broadwater, Steve Carter, Edmonds, Emerson, Falconer, Hall, Hilferty, Price, Simon, and Smith voted yea.

Representative Edmonds offered a motion to report House Bill No. 133 favorably. Without objection, House Bill No. 133 was reported favorably by a vote of 8 yeas and 0 nays. Representatives Nancy Landry, Amedee, Edmonds, Falconer, Hall, Hilferty, Simon, and Thomas voted yea.

House Bill No. 122 by Representative Pierre
