## III. DISCUSSION OF LEGISLATION

## House Bill No. 241 by Representative Chad Brown

Representative Chad Brown presented House Bill No. 241, which expands requirements within driver education and prelicensing training courses.

Representative Terry Landry offered an amendment to make a technical change. Representative Terry Landry offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 13 yeas and 0 nays. ## House Bill No. 257 by Representative Hollis

Representative Hollis presented House Bill No. 257, which provides relative to the use of traffic cameras.

- 1. Clarify the provision in this act will not interfere with the use of these cameras' features or function that enable law enforcement to search for wanted vehicles.
- 2. Require the political subdivision to cease use by November 13, 2017.
- 3. Make technical changes to the title.

# **House Bill No. 547 by Representative Hazel**

Representative Hazel presented House Bill No. 547, which provides for an additional fee on driver's license applications to benefit the Military Family Assistance Fund.

Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. ## **House Bill No. 437 by Representative White**

Representative White presented House Bill No. 437, which authorizes an alternative method of instruction for the classroom portion of approved prelicensing training courses.

- 1. Make technical changes.
- 2. Clarify that the classroom instruction portion of the prelicensing training course is six hours and is available to those persons 18 years of age or older.
- 3. Prohibit persons under the age of 18 from participating in the alternative method of instruction that does not require students to be present in a traditional classroom.

Representative Terry Landry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. # **House Bill No. 465 by Representative Steve Carter**

Representative Steve Carter presented House Bill No. 465, which establishes maximum speed limits for certain motor vehicles on interstate highways.

a vote of 12 yeas and 0 nays. Representatives Terry Landry, Terry Brown, Carpenter, Steve Carter, Franklin, Gisclair, Hall, Hill, Norton, Pierre, Pope, and Stefanski voted yea.

# House Bill No. 496 by Representative Norton

Representative Norton presented House Bill No. 496, which provides with respect to special license plates for firefighters with twenty years of service.

Representative Terry Landry offered amendments to:

- 1. Make technical changes.
- 2. Remove active, full-time professional firefighters from those eligible for the registration fee exemption.
- 3. Add a provision that requires those firefighters applying for the fee exemption to submit a certification from their retirement system attesting to their eligibility.

Representative Terry Landry offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 years and 0 nays. Representatives Terry

Landry, Terry Brown, Carpenter, Franklin, Gisclair, Hall, Hill, Norton, Pierre, Stefanski, and White voted yea.
