III. DISCUSSION OF LEGISLATION

House Bill No. 483 by Representative Gary Carter

Representative Gary Carter presented House Bill No. 483, which provides for the seizure of firearms from persons who pose a risk of imminent injury to self or others.

On behalf of the author, Representative Marcelle offered amendments to remove from proposed law the authority by which two peace officers may petition the court for the issuance of a warrant authorizing the search and seizure of firearms. Representative Marcelle offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Bacala, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, Marcelle, Marino, Moss, and Muscarello voted yea. Representative Mack abstained.

Representative Marcelle offered amendments to authorizes the court to order that the person be taken into protective custody and transported to a treatment facility for immediate examination instead of requiring the court to provide a notice to the Louisiana Department of Health to take action that it deems appropriate and necessary. Representative Marcelle offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bagneris, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, Marcelle, Marino, Moss, Muscarello, and Norton voted yea. Representative Mack abstained.

Senate Concurrent Resolution No. 18 by Senator Morrell

On behalf of Senator Morrell, Representative Duplessis presented Senate Concurrent Resolution No. 18, which provides for a Task Force on Secure Care Standards and Auditing.

Representative Marcelle offered a motion to report Senate Concurrent Resolution No. 18 favorably. Without objection, Senate Concurrent Resolution No. 18 was reported favorably by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bagneris, Carpenter, Crews, Duplessis, Gaines, Hodges, Howard, James, Marcelle, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Senate Bill No. 146 by Senator Morrell

On behalf of Senator Morrell, Representative Duplessis presented Senate Bill No. 146, which limits the incarceration of victims of domestic violence and sex offenses who refuse to testify against their abusers.

On behalf of Senator Morrell, Representative Marcelle offered amendments to:

- (1) Specify that a judge shall not order a material witness warrant solely to secure the attendance or testimony of a victim listed in the indictment or bill of information in a felony prosecution.
- (2) Specify that "dating partner" for purposes of proposed law has the same meaning as provided in the present law Protection from Dating Violence Act.
- (3) Change certain references in proposed law from "witness" to "victim".
- (4) Provide that only a qualified victim for which a material witness warrant is being sought pursuant to proposed law shall have standing to raise the protections provided in proposed law.
- (5) Provide that a victim who is indigent shall be authorized to apply for counsel for a bond hearing, instead of a providing the victim with a right to appointed counsel.
- (6) Change references in proposed law from "criminal justice agency" to "district attorney or other prosecution agency"
- (7) Change references in proposed law from "Department of Justice" to "Louisiana Commission on Law Enforcement and Administration of Criminal Justice".
- (8) With regard to the required reporting of information about the number of material witness warrants applied for, specify that the report shall only include those warrants that are applied for pursuant to proposed law and have been filed into the record of any criminal prosecution proceeding within their jurisdiction.
- (9) Remove the requirement that the report include the name and contact information of agencies that have failed to submit reports required under proposed law.
- (10) Make technical corrections.

Representative Marcelle offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas, 0 nays, and 1 abstention. Representatives

Representative Dwight offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bagneris, Carpenter, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, James, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Duplessis offered an amendment to reduce the number of representatives on the commission for Louisianans for Prison Alternatives from two to one. Representative Duplessis offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 15 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bagneris, Carpenter, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, James, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Senate Bill No. 153 by Senator Martiny

Senator Martiny and Representative Marino presented Senate Bill No. 153, which provides relative to sports wagering.

Representative Marino offered amendments to:

- (1) Authorize the La. Gaming Control Board to impose civil penalties to any holder of a sports wagering certificate who violates the proposed law Sports Wagering Control Act.
- (2) Remove the provision of proposed law which provided that submission of applications for a sports wagering certificate begin on Jan. 1, 2020.
- (3) Add a requirement that the holder of a sports wagering receipt shall claim any winnings within 90 days after the date of the conclusion of the sports event. Further provide that any unclaimed monies are required to be deposited into the present law Crime Victims Reparations Fund.
- (4) Change the amount of money given to the Compulsive Gaming and Problem Fund from one percent of net sports wagering proceeds or \$500,000, whichever is greater. If one percent exceeds \$500,000, then the remainder of the monies collected shall be credited to the La. Early Childhood Education Fund.
- (5) Provide that 10% of monies collected shall be credited to the La. Early Childhood Education Fund.
- (6) Provide that two percent of monies collected shall be remitted, by proportionate distribution, to each parish governing authority in which the taxable conduct occurred.
- (7) Provide that the proposed law provisions relative to the dedication of revenue shall not become effective if the provisions of R.S. 27:609 and 610 as enacted by the Act which originated as House Bill No. 587 of the 2019 R.S. become effective.
- (8) Make technical corrections.

Representative Marino offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 16 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bagneris, Carpenter, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, James, Marcelle, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Marcelle offered an amendment to change the amount of money given to the Compulsive Gaming and Problem Fund from one percent of net sports wagering proceeds or \$750,000, instead of \$500,000. Representative Marcelle offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 16 yeas, 0 nays, and 1 abstention. Representatives Bacala, Bagneris, Carpenter, Crews, Duplessis, Dwight, Gaines, Hodges, Howard, James, Marcelle, Marino, Moss, Muscarello, Norton, and Pylant voted yea. Representative Mack abstained.

Representative Bagneris offered an amendment to require a total of six percent of net sports wagering proceeds to be distributed to the pari-mutuel wagering facilities and the horse breeding industry.
