III. DISCUSSION OF LEGISLATION

House Bill No. 139 by Representative Marino

On behalf of the author, Representative Bacala offered a motion to voluntarily defer action on House Bill No. 139, a constitutional amendment which adds aggravated battery committed with a firearm to the list of crimes for which special juvenile procedures are not required. Without objection, action on House Bill No. 139 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 645 by Representative Jordan

On behalf of the author, Representative Bacala offered a motion to voluntarily defer action on House Bill No. 645, which provides relative to inmate visitation. Without objection, action on House Bill No. 645 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 855 by Representative Duplessis

On behalf of the author, Representative Bacala offered a motion to voluntarily defer action on House Bill No. 855, which provides with respect to the early release of certain offenders under certain circumstances. Without objection, action on House Bill No. 855 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Concurrent Resolution No. 39 by Representative Bishop

On behalf of the author, Representative Bacala offered a motion to voluntarily defer action on House Concurrent Resolution No. 39, which temporarily suspends the payment of video draw poker device operation fees due to the closure of licensed establishments as a result of COVID-19. Without objection, action on House Concurrent Resolution No. 39 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 522 by Representative James

On behalf of the author, Representative Bacala offered a motion to voluntarily defer action on House Bill No. 522, which provides relative to collection and reporting of data regarding jail facilities. Without objection, action on House Bill No. 522 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 670 by Representative Stefanski

Representative Stefanski presented House Bill No. 670, which provides relative to the criteria and amenity requirements for qualified truck stops.

On behalf of the author, Representative Muscarello offered an amendment relative to the present law criteria and amenity requirements for qualified truck stops, requiring force majeure to be in effect beginning March 17, 2020, through June 30, 2021, due to the COVID-19 pandemic. Representative Muscarello offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Seabaugh voted yea.

Representative Bacala offered a motion to report House Bill No. 670 with amendments. Without objection, House Bill No. 670 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Seabaugh voted yea.

House Bill No. 368 by Representative Mack

Representative Mack presented House Bill No. 368, which provides relative to qualified truck stop facilities.

On behalf of the author, Representative Muscarello offered an amendment to provide that any qualified truck stop facility that is required to rebuild pursuant to proposed law shall be in accordance with local, state, or federal basic flood elevation standards rather than building code standards. Representative Muscarello offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Marino offered a motion to report House Bill No. 368 with amendments. Without objection, House Bill No. 368 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 89 by Representative James

On behalf of Representative James, Representative Villio presented House Bill No. 89, which adds certain substances to the Uniform Controlled Dangerous Substances Law.

On behalf of the author, Representative Bacala offered amendments to:

- (1) Add Butyryl fentanyl, 4-Fluoroisobutyryl fentanyl, MT-45, and Ocfentanil to Schedule I;
- (2) Remove isomers of opium and opiates from Schedule II substances of vegetable origin or chemical synthesis and add 6 β -naltrexol as a Schedule II substance of vegetable origin or chemical synthesis;
- (3) Add Norfentanyl to Schedule II;
- (4) Add Brexanolone and Lemborexant to Schedule IV; and
- (5) Add Cenobamate and Lasmiditan to Schedule V.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 65 by Representative Dwight

On behalf of Representative Dwight, Gary Bennett, Louisiana Sheriffs' Association, 1175 Nicholson Dr., Baton Rouge, LA 70802, (225) 343-8402, presented House Bill No. 65, which provides relative to exceptions to the crime of political payroll padding by a sheriff.

Representative McKnight offered a motion to report House Bill No. 65 favorably. Without objection, House Bill No. 65 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative DeVillier presented House Bill No. 77, which provides relative to the supervision and reporting requirements of persons on probation or parole.

Representative Muscarello presented House Bill No. 57, which provides for the functions of the jury commission in Tangipahoa Parish and Jackson Parish.

House Bill No. 257 by Representative Muscarello

Representative Muscarello presented House Bill No. 257, which provides relative to the form of payment for expungement of a record.

Representative Marino offered a motion to report House Bill No. 257 favorably. Without objection, House Bill No. 257 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 179 by Representative Marino

Representative Marino presented House Bill No. 179, which provides relative to certain conditions to expunge a record of arrest and conviction of a felony offense.

Representative Villio offered a motion to report House Bill No. 179 favorably. Without objection, House Bill No. 179 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 194 by Representative Marino

Representative Marino presented House Bill No. 194, which provides relative to certain expungement forms.

Representative Villio offered a motion to report House Bill No. 194 favorably. Without objection, House Bill No. 194 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 99 by Representative Marino

Representative Marino presented House Bill No. 99, which re-creates the Department of Public Safety and Corrections.

Representative Villio offered a motion to report House Bill No. 99 favorably. Without objection, House Bill No. 99 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 759 by Representative Marino

Representative Marino presented House Bill No. 759, which provides for the suspension of certain time periods, limitations, and delays in declared states of disaster, emergency, or public health emergency.

Representative Villio offered a motion to report House Bill No. 759 favorably. Without objection, House Bill No. 759 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 775 by Representative Marino

Representative Marino presented House Bill No. 775, which provides relative to a defendant's appearance at certain proceedings by audio-visual transmission.

Representative Villio offered amendments to: (1) add that the court, by local rule, may provide for a defendant's appearance at the pronouncement of sentence by simultaneous audio-visual transmission in accordance with certain provisions of present law and proposed law; and (2) provide that the provisions of present law and proposed law providing procedures regarding the use of simultaneous audio-visual transmission for certain proceedings apply to the defendant's appearance in such manner at the entry of his plea of guilty, at any revocation hearing for a probation violation, and at sentencing and do not apply to the defendant's appearance at arraignment and at any preliminary matter or pretrial conference that does not involve the taking of testimony. Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Villio offered an amendment to restore the present law requirement that the district attorney's consent be obtained in order for the defendant to appear at the entry of his plea of guilty, at any revocation hearing for a probation violation, including any hearing for a contempt of court, or at sentencing by simultaneous audio-visual transmission. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Marino offered a motion to report House Bill No. 775 with amendments. Without objection, House Bill No. 775 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

House Bill No. 178 by Representative Marino

Representative Marino presented House Bill No. 178, which provides relative to the suspension or deferral of sentence and probation in felony cases.

Representative Marino offered an amendment to increase the limitations on the number of dismissals from prosecution pursuant to present law from not more than once to not more than twice. Representative Marino offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

Representative Marino offered an amendment to restore the present law prohibition on deferral of a sentence for certain violations of the Uniform Controlled Dangerous Substances Law, except that the prohibition will only apply to offenses punishable by a term of imprisonment for more than 10 years. Representative Marino offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Representative Marino offered a motion to report House Bill No. 178 with amendments. Without objection, House Bill No. 178 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, Seabaugh, and Villio voted yea.

Without objection, House Concurrent Resolution No. 2 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

- (1) Two representatives from the Association of Louisiana Bail Underwriters;
- (2) Two representatives from the American Bail Coalition; and
- (3) Two representatives, chosen and appointed by the commission, representing the interests of victims.

Representative McKnight offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

Representatives Bacala, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

On behalf of the author, Representative Jones presented House Bill No. 137, which repeals the crime of vagrancy.

Representative Villio offered an amendment to add that proposed law shall have prospective application only and shall have no effect on the lawfulness of any arrest, conviction, or sentence which occurred prior to the effective date of proposed law. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

Representative Jones offered a motion to report House Bill No. 137 with amendments. Without objection, House Bill No. 137 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

- (1) Remove the proposed law requirement for the Louisiana Bureau of Criminal Identification and Information to cooperate with nonprofit partners that provide technical assistance to study groups, task forces, and commissions legislatively established to study and evaluate certain processes and procedures involving criminal history records;
- (2) Specify the purposes for which the bureau may provide certain de-identified arrest and conviction information; and
- (3) Specify the nonprofit partners eligible to receive the de-identified arrest and conviction information and the duties of the nonprofit partners with respect to such information.

Representative Marino offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Bacala, Bryant, Fontenot, Goudeau, Jones, Marino, McKnight, Muscarello, Nelson, and Villio voted yea.

Representative Marino offered a motion to report House Bill No. 510 with amendments. Without objection, House Bill No. 510 was reported with amendments by a vote of 10 yeas and 0 nays.
