III. DISCUSSION OF LEGISLATION

House Concurrent Resolution No. 60 by Representative Kerner

Representative Kerner presented House Concurrent Resolution No. 60, which memorializes Congress to appropriate additional money for increased seafood testing.

Representative Romero offered amendments to add a cap of 10,000 square feet on the total land size of the repair work. Representative Romero offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives McFarland, Bourriaque, Bryant, Butler, Deshotel, Travis Johnson, McCormick, McMahen, Mincey, Riser, Romero, Selders, St. Blanc, Thompson, and Wheat voted yea.

Representative Bryant offered a motion to report Senate Bill No. 163 with amendments. Without objection, Senate Bill No. 163 was reported with amendments by a vote of 15 yeas and 0 nays. Representatives McFarland, Bourriaque, Bryant, Butler, Deshotel, Travis Johnson, McCormick, McMahen, Mincey, Riser, Romero, Selders, St. Blanc, Thompson, and Wheat voted yea.
