III. DISCUSSION OF LEGISLATION

House Bill No. 164 by Representative Davis

Representative Davis presented House Bill No. 164, which provides relative to emergency medical services protocols in certain life-threatening situations.

Representative Stagni offered amendments which:

- (1) Amend present law relative to emergency medical services (EMS) practitioner students administering automated cardiac defibrillation under certain conditions to provide that protocols for this activity shall be approved by the local parish medical society, or its designee, or the EMS medical director;
- (2) Revise present law and proposed law to stipulate that, if a parish has no organized or functional local medical society, the requirements of present law and proposed law for approval of an EMS protocol may be satisfied by the EMS medical director;
- (3) Amend present law relative to licensure of ambulance providers to provide that applicants for such licensure shall include with their applications all medical protocols signed by the EMS medical director or by the parish or component medical society;
- (4) Amend present law relative to licensure of air ambulance services to provide that applicants for such licensure shall submit to and successfully complete an inspection that includes a review of medical protocols signed by the EMS medical director of the air ambulance service or the president or designee of the parish or component medical society in the service's parish of domicile; and
- (5) Make technical changes.

Representative Lyons presented House Bill No. 243, which exempts persons with disabilities from charges associated with obtaining medical records.

Representative Stagni offered a motion to voluntarily defer action on House Bill No. 243. Without objection, action on House Bill No. 243 was voluntarily deferred by a vote of 14 yeas and 0 nays. House Bill No. 835 by Representative McMahen

Representative McMahen presented House Bill No. 835, which authorizes local hospital assessments in certain parishes to fund the nonfederal share of Medicaid costs of health care provided in those parishes.

Representative McMahen offered amendments which:

- (1) Add any parish with a population of not less than 46,000 persons and not more than 47,000 persons according to the most recent federal decennial census (Lincoln Parish) as a parish in which local hospital assessments may be instituted in accordance with proposed law;
- (2) Provide that any parishes authorized by proposed law to establish a local provider participation fund may, upon agreement of the governing authorities of each parish, establish all of the following:
 - (a) A single fund for the benefit of those parishes;
 - (b) A local hospital assessment applicable to the institutional providers, as defined in proposed law, in those parishes; and
- (3) Make technical changes.

Representative McMahen offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Echols, Hughes, Travis Johnson, Larvadain, McMahen, Pressly, Selders, and Stagni voted yea.

Representative Turner offered a motion to report House Bill No. 835 with amendments. Without objection, House Bill No. 835 was reported with amendments by a vote of 12 yeas and 0 nays. Representative Bagley offered amendments which provide that any physician licensed by and in good standing with the Louisiana State Board of Medical Examiners may recommend medical marijuana. Representative Bagley offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Crews, Travis Johnson, Larvadain, McMahen, Robert Owen, Selders, and Stagni voted yea.

- (2) Delete the following conditions for participation in remote patient monitoring:
 - (a) A requirement that the patient's diagnosis shall have occurred within the previous 18 months;
 - (b) A requirement that the patient have a recent history of costly service use due to one or more chronic conditions as evidenced by two or more hospitalizations, including emergency room visits, in the last 12 months;
- (3) Provide that the remote patient monitoring management plan shall encompass all provisions listed in proposed law rather than one or more of those provisions;
- (4) Revise a reference to telemedicine to refer instead to telehealth;
- (5) Provide that remote patient monitoring services through telehealth shall include the ability to monitor multiple chronic diseases simultaneously, including behavioral health conditions;

(6) Require that telemedicine and other telehealth services related to remote patient monitoring shall be covered services in the state Medicaid program in addition to the remote patient monitoring services themselves; and

(7) Make technical changes.

Representative Bagley offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Bagley, Turner, Adams, Cox, Crews, Echols, Hughes, Travis Johnson, Larvadain, McMahen, Robert Owen, Pressly, Selders, and Stagni voted yea.

Representative Pressly offered amendments in concept to delete the requirement provided in proposed law that remote patient monitoring shall be a covered service in the state Medicaid program. Representative Pressly offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays.
