#### III. DISCUSSION OF LEGISLATION

## House Bill No. 64 by Representative Echols

Representative Echols presented House Bill No. 64, which provides relative to misleading solicitations by nongovernmental entities which imply certain governmental connections.

Secretary R. Kyle Ardoin, Secretary of State, P.O. Box 94125, Baton Rouge, LA 70804, (225) 922-2880, spoke for information only and provided a handout, Exhibit A, which is included in the committee records.

Representative Davis offered a motion to report House Bill No. 64 favorably. Without objection, House Bill No. 64 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, and Villio voted yea.

## House Bill No. 465 by Representative Mike Johnson

Representative Mike Johnson presented House Bill No. 465, which provides relative to the leasing of the 4.9 GHz band.

Representative Davis offered technical amendments to House Bill No. 465. Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

Mr. Eric Peterson, Pelican Institute, 400 Poydras St., New Orleans, LA 70130, no phone number provided, spoke in support of House Bill No. 465.

Representative McCormick offered amendments to remove the requirement that auction winners, incumbents, and entities using the 4.9 GHz band for public safety include an estimate of moving current 4.9 GHz band to 5 GHz band in the report submitted to the office. Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Hilferty, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

Ray Sabourin, NOKIA, 3201 Olympus Blvd., Dallas, TX 75019, (678) 427-6415, spoke in support of House Bill No. 465.

Representative Thomas offered a motion to report House Bill No. 465 with amendments. Without objection, House Bill No. 465 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Hilferty, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

# **House Bill No. 360 by Representative Travis Johnson**

Representative Travis Johnson presented House Bill No. 360, which provides relative to the registration of short-term rental dwellings with the office of state fire marshal.

Representative Davis offered amendments to:

- (1) Clarify that the office of state fire marshal is authorized to promulgate rules and regulations as necessary relative to enforcing fees and penalties, operating, managing, and maintaining the electronic registration system, investigating compliance with the registration requirements, and hearings.
- (2) Add a provision stating that proposed law shall not be construed to authorize the office of state fire marshal to inspect any real property, including a private residence.
- (3) Add a provision stating that proposed law shall not be construed to apply to the regulation of certain structures already provided for in present law.

Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Hilferty, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

Fire Marshal Butch Browning, Louisiana State Fire Marshal, 8181 Independence Blvd., Baton Rouge, LA 70806, (225) 806-0807, spoke for information only.

Representative Newell offered a motion to report House Bill No. 360 with amendments. Without objection, House Bill No. 360 was reported with amendments by a vote of 15 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Green, Hilferty, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

# House Bill No. 69 by Representative McKnight

Representative McKnight presented House Bill No. 69, which provides relative to underground utilities.

Representative Davis offered technical amendments to House Bill No. 69. Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Green, Hilferty, Jordan, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

Representative Davis offered amendments to:

- (1) Change the physical marking requirement for the location of excavation or demolition from requiring color coded markings to white markings.
- (2) Remove a provision which calls for electronic drawings to supercede physical markings.

Representative Davis offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Davis, Duplessis, Fontenot, Geymann, Goudeau, Green, Hilferty, Jordan, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

Representative Hilferty in the chair.

Representative Newell offered a motion to report House Bill No. 69 with amendments. Without objection, House Bill No. 69 was reported with amendments by a vote of 13 yeas and 0 nays. Representatives Duplessis, Fontenot, Geymann, Goudeau, Green, Hilferty, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

# House Bill No. 476 by Representative Schamerhorn

Representative Hilferty offered a motion to voluntarily defer action on House Bill No. 476, which provides relative to broadband. Without objection, action on House Bill No. 476 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Duplessis, Fontenot, Geymann, Goudeau, Green, Hilferty, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.

# **House Bill No. 466 by Representative Jordan**

Representative Hilferty offered a motion to voluntarily defer action on House Bill No. 466, which provides relative to credit unions. Without objection, action on House Bill No. 466 was voluntarily deferred by a vote of 13 yeas and 0 nays. Representatives Duplessis, Fontenot, Geymann, Goudeau, Green, Hilferty, McCormick, McKnight, Newell, St. Blanc, Tarver, Thomas, and Villio voted yea.
